**33 Cummins, Thomas June 16[v 2 PG 35]**

Depositions taken at the claimants house by the President June 11<sup>th</sup>.

Kamaka sworn, deposed that her Father gave her the land claimed by Mr. Cummins, at the time Governor Adams had charge of the Fort, and that the ground had been previously fenced by her father.

Keauiaole, sworn deposed that Kaahumanu gave him the land claimed by Mr Cummins at the time Governor Adams came down to take charge of Oahu, that he enclosed it with a fence, and subsequently gave it to his daughter Kamaka, and to her husband Mr. Cummins, at the time of Kaomis violous conduct. No person has to his knowledge denied his or their right to the place. The fence now surrounding the premises constitutes the correct boundaries of what belongs to Mr. Cummins.

**264 Thomas Cummins Cont Nov 24**

Situated near Waititi. The deed is dated 6<sup>th</sup> Nov. 1845, and signed by George C. Allan, Anthony D. Allen, by his brother, and Sally Allen, and witnessed by John H. Jasper and afterwards signed by Anthony D. Allen in person and this day acknowledged his signature to the Board.

Wm Wood swore and stated that he was witness to the signature.

**154 William Sumner (see pg 108, vol. 1) Sept 29 [v 2 pg 509]**

A tract of land called Kuilei, Kona, Waititi.

Lahilahi sworn. I know this land called Kuilei, it consists of Kalo land principally, and some Kula. I was born near it and have lived there all my life. I cannot give the exact number of Kalo patches, it consists of 4 distinct pieces, and one of sea, called Ele, beyond Claimants hill. I went with Kalanikahua (surveyor) when he surveyed it and the bounds given in these survey are correct, which I can point out at any time, there are several tenants living on this land and having rights therein.

Mr. Sumner got this land in time of Kamehameha 2 in 1822 or 1823, and he and his heirs have held them ever since in peace and quietness. I am headman of this land.

Mr. Sumner on part of the heirs said he did not wish to disturb the right of the Tenants there, he fully recognized their rights.

Kapanui sworn. I know this land of Kuilei, I formerly live on it, I know it was given to William Sumner by Kamehameha II and he and his heirs have occupied it ever since that time.

**236 Kaluahinenui Oct 15 [v 2 pg 38]**

Standing in the list no. 804, this being his first application.

John li sworn, stated he knows the place, which is East of Honolulu. Beretania St. is North, Kekuiau's is East, Maakhahia South and Kaauahua's, John li's and a water course West. Claimant has lived there since 1829. There is a fence, house, well and Garden on it. Witness does not certainly know the

grounds of the claim, but at the time the Claimant went to him the place was waste, and it was then the custom to occupy any vacant spot near the Mission.

Witness knows of no other Claimant to the place, there are some living there as tenants.

Kaloi sworn, knows the place and confirms the Boudaries just given by Mr. Ir. He know of Claimant living there since 1831. It is enclosed and built upon by Claimant who has lived there from the first, and owned the place exclusively, and took it up as stated by Mr. li.

Freehold title given.

Note: This claim was tentatively ? before it was known the present Claimant of the said name had been cited and stands.

**922 Okuu April 3 [v 2 pg 262]**

Kupanihi sworn. I know this place, it is a houselot in Waititi; bounded Ewa by Kukuahu's; mauka by John li's; Waititi by Nuu's and Hope's; makai by the sea. It has an adobe fence and five houses, one belonging to Ku, one to myself, 1 to Kini, and two to Claimant, who got the place from Kamaukoli, who had it from Kaahumanu, in whose time Okuu came by it (about 1822). I know of no other person claiming it but him.

Kini sworn, and confirmed all the previous particulars.

**1116 Kaioe. Counter 566 J. Milchenir, See 566 Oct. 6 [v 3/2]**

Claimant is wife of John Milchenir.

Kamaikahulepu sworn. I know this land, it is in the ili of Pawaa, Waititi, consisting of a house lot with 5 houses on it. Formerly occupied by John Milchenir. Bounded Mauka by Waititi road, Waialae by Kauliokamoa's, Makai by Kealoha's, Honolulu by Kaaha's.

Claimant had this land from Kinau when Milchenir her husband was in England about 1833. She begged this place from Kinau for her own land. Milchenir had a small piece of Pond at Waititi, near this, given him by the King before he went, and he left this with Claimant, when he came back he lived with her, and built 4 houses on the land, and Claimant built the 5<sup>th</sup> house on it. He lived with her when he was sober, and away from home. Claimant has lived on or near this land ever since she had it from Kinau. Milchenir sailed to California or elsewhere in 1847 and I heard left his wife nothing to live on. I understand the property is now in possession of Stackey Janion and Co.

In Dec. 22, 1850 Claimant gave up her separate claim to a part of her husbands before ? and W. Robertson this day on the lot.

**1150 Kaiwi July 7 [v 2 pg 378]**

Ua sworn. This land is called Kamakela, Honolulu aina. Consisting of a house lot and Kalo land; bounded mauka by Niho's place; Waititi by my land; makai by Wahine's; Ewa by Poonui's. Claimant has one house on it, and two Kalo patches, it is not fenced. Claimant got it from Kalaiokekoe in Kinau's time, and it has never been disputed to the present time.

Paupau sworn. Confirmed all the preceding testimony.

**1263 Kauhane 1 September [v 2 pg 455]**

Kekukahikio sworn. This land is in the ili of Kalawai, Waititi, in 3 pieces in Kalawa's and 1 in Makapela.

1 House lot in Makapela-being a strip and 2 Kalo patches and having 1 house: bounded mauka by Kahalehaie's; Waimanalo by Kahialii's (teacher); makai by my lands, Honolulu by Uma's.

2 Three Kalo patches: mauka by my lands; Waimanalo by Napahi's; makai by my lands; Honolulu by Kamakahonu's.

- 1 One Kalo patch; bounded mauka by Uma's; Waimanalo by my land, makai by land of Kolau, Honolulu by Kaluahinaniu's.

Kula land only bounded mauka by Kahanamaikai's; Waimanalo by Keolaloa's; makai by Kahiahinenui's; Honolulu by the King's lands.

I gave Claimant the 3 last lands in 1842, being a Konohiki of them and was there. The 1<sup>st</sup> was waste, and claimant went long ago to live there, and has ever since lived there without dispute.

L. Kaaui sworn, confirmed the testimony of above but could not speak certainly of the 1<sup>st</sup> land.

**Kekukahikio was the konohiki of Kalawai.**

**1265 Kamoho 1 September [v 2 pg 455]**

Mauwele sworn. This land is in Paakea, Waititi in 4 pieces.

1 House lot with one house bounded mauka by Kaaha's; Waimanalo by Pahau's; makai by Kahauawai's; Honolulu by Kaaha's.

2 One Kalo patch, bounded mauka by Kalahoa's; Waimanalo by Pahau's; makai by Puapuia's; Honolulu by Kaaha's.

3 One Kalo patch bounded mauka by my lands; Waimanalo by Pahau's; makai by Kaaha's; Honolulu by Kaniahi's.

- 2 One Kalo patch, mauka by Paukuwahie's; Waimanalo by Hopuia's; makai by Poai's; Honolulu by Kaoluaana's.

Kaaha gave Claimant these lands in 1844 and he has ever since held it without dispute.

Kaaha's testimony wanted.

**1266 A. Hopuia 7 September [v 2]**

Kaluahine sworn. This land is in ili of Maulukikepa, Waititi, in 4 pieces.

1 House lot with a Kalo patch, it is within the Govt, There is one house, bounded by Govt fence mauka; Waimanalo by Maliemu's; makai by Kaauwai's and Kealoha's, Honolulu by Kaaha's and Govt fence.

2 One Kalo patch, mauka by Kaha's; Waimanalo and makai by Kinopu's; Honolulu by Kupawa's.

3 One Kalo patch, mauka by Kaaloo's; Waimanalo by Mauiweli's; makai and Honolulu by Kuiopu's.

4 One Kalo patch, mauka by Kaohipua's; Waimanalo by Hepa's; makai by Lailoa's; Honolulu by Haole's.

Kaihe Kouohiki under the King gave Claimant these lands in 1831, and has ever since held them without dispute.

Lailoa confirms the testimony as above and know of no other claimants than Hopuia.

**1266-B Loiloo 1 September [v 2 pg 455]**

Hopuia sworn. This land in ili of Maulukikepa, Waititi, in 3 pieces; two of them in Maulukekepa and one in Kaalawai.

1 One Kalo patch in Kaalawai; bounded mauka by Kekuhahilia's; Diamond Hill by Kaanaana's; makai by Kekukahilio's; Honolulu by Kaluahua's.

2 Small piece of dry land and two Kalo patches, with a house. Mauka by my lands; Waimanalo by Kealaloo's; makai by Kealoha's; Honolulu by Kaaha's.

3 One Kalo patch in Maulukikepa; mauka by my lands, Waimanalo by Kamaha's; makai by Puaiku's; Honolulu by Pukine's.

The first piece Claimant had from Kauhane Luna was the King, the other two I gave him, I being under Kuiki, a Konohiki under the King, he had them in 1843 and has ever since held them without dispute.

Kauhane sworn, confirmed the testimony in every part.

**Kuiki is Konohiki of Maulukekepa, Hopuia under him.**

**1269-B Kaluahine 1 September[v 2 pg 457]**

Hopuia sworn. This land is in Paakea, Waititi, 3 pieces.

1 House lot, one house. This land is Kaaha's, and Claimant has only a right of residence. Kaaha's land is all round it.

2 Kula land only, bounded mauka by Kaaha's; Waimanalo by my land; makai by Kealoha's; Honolulu by Kaaha's.

3 Three Kalo patches. Mauka by Kaaha's; Waimanalo by Kaauwai's and Kekukahiko's; makai by Uluko's; Honolulu by Paele's.

Kaaha gave these lands to Claimant in 1839 and he has held them ever since without dispute.

Poiloa sworn. Confirmed the preceding testimony.

**1271 Kamana Sept 4 [v 2 pg 458]**

Nakai sworn. This land is in the ili of Kiki, Waikiki, Oahu, consisting of 2 pieces:

1 Kalo lands in Kiki, 2 patches; bounded mauka by lands of Kekualoa; Waimanalo by Nahuli's; makai by Paukuwahie's; Waiania's land is on the Honolulu side.

2 House lot in Waiaka; bounded mauka by Kahakai's; Waimanalo by Govt lands or fence; makai by Kaihe's; Honolulu by the same.

Claimant had these lands from his father Kepalu in 1825 by lide(?)a, and has ever since held them in peace. Paukulowahie is Claimant's Konohiki.

Kapaaa sworn, and confirms the above account.

**Paukulowahie is the konohiki of Kiki.**

**1272 Mauele Sept 4 [v 2 pg 458]**

Kaaha sworn. I know this land, it is in four distinct pieces, two in Paahea, one in Hopoe, one in Kealoha.

1 One Kalo patch in Paakea; bounded mauka by Mookini's; Waimanalo by Pahuka's; Makai by Mookini's; Honolulu by Kopuia's.

2 One Kalo patch in Hopoe; bounded mauka by Kahoa's II; Waimanalo by Poai's; makai by Kakakoa's; Honolulu by Kekukahiko's.

3 One Kalo patch; bounded mauka by Muole's; Waimanalo by Pahao's; makai by Moho's; Honolulu by Mohono's.

4 House lot in lands of which Kealoha is Konohiki, having two houses on it (or there are two on it); bounded mauka by Good fence and Kealoha's; Waimanalo by lands of Kealoha, makai by Kaihiwa's; Honolulu by my lands. I gave these lands to Claimant in 1842, and there is no question of his Title. I had them from Kekauluohi. I am Konohiki and so long as Claimant does poalima work the land is his.

**1275 Mookini Sept 6 [v 2 pg 458]**

Kaaha sworn. This land is in ili of Paakea, Waititi, in 4 lots.

1 House lot, having 1 house fenced with stone; bounded mauka by Govt fence; Waimanalo by Kekualoa's kula land; makai also; Ewa by Kekuanaoa's fish pond.

2 One Kula patch; mauka by Kupa's; Waimanalo by Peleuli's; makai by Mauele's; Ewa by Kealoha's.

3 Kalo patch; mauka by Mauole's; Waimanalo by Peleuli's; makai by Kuela's; Ewa by Kapuia's.

4 One Kalo patch; mauka by Kaole's; Waimanalo by Mauikana's; Ewa by Kupa's; makai by Moehau's.

Claimant had this lands in time of Kamehameha I, and has lived there ever since without dispute. I am luna of it under Kekuanaoa.

**1276 Poai Sept 6 [v 2 pg 458]**

Kaaha sworn. This land is in Paakea Waititi, and is in 3 pieces.

1 House lot, with 1 house, within the Paaina; bounded mauka by my lands; Waimanalo by Kaaha's; and on the other two sides.

2 Two Kalo patches; bounded mauka by Paele's; Waimanalo by Kupa's; and makai; Ewa by Govt. fence.

3 One Kalo patch; bounded mauka by Moho's; Waimanalo by Keopuia's; makai by Haole's; Ewa by Hopoe (land).

Claimant is a son of the land. He has had this ever since the Kauai war in 1825, and has ever since lived on it in peace under me as luna and no counter Claimant.

Mookini sworn. Confirms the testimony as above.

**1277 Samuela Sept 6 [v 2 pg 458]**

Kaluahine sworn. This land is in Paakea, Waititi, in two pieces.

1 One Kalo patch; bounded mauka by Kuaha's land; Waimanalo by Pahau's; makai by Moho's; Ewa by Kekuanoa's fish pond.

2 One Kalo patch; mauka and Waimanalo by Kupa's; makai by Kaha's and Kekukahiko's; Ewa by Moho's.

Kawelo gave Samuela this land in 1826 and he had them from Kaaha, there is no counter claimant.

Kawelo sworn. I received these patches from Kaaha in 1846 and gave them to Claimant.

Kaaha sworn. The testimony of the foregoing witnesses is true and I know of no counter claimant.

**1281 Kuhulwailehua Sept 4 [v 2 pg 458]**

Kahiawaawa sworn. I know these lands, they are an ili in Waititi, called Kamahuakahi, Oahu. Claimant presented a paper from the Minister of Finance showing the land Kamoku was set aside to Claimant in the division of Lands, stating there were 8 natives (Hoainas) living on the lands as his tenants, whose names are: Kahiawaawa; 2 Anee; 3 Malo; 4 Keaka; 5 Haole; 6 Kaeina; 7 Kalaione; 8 Kahiamoe; 9 Kawelohealii; 10 Kaua.

These men are not Counter Claimants, and Claimant says he does not wish to disturb the rights of these tenants.

Claimant has 5 Kalo patches and a house lot in "Kamakuelua", which is Kanaians or William Lunalilo's lands. (Postponed till 6<sup>th</sup> day).

I know the Kalo patch claimant has in "Kuilei", it is bounded by Hao's land mauka, Waimanalo by Namekanu's; makai by a small road; Waititi by an auwai and the land of Kaaha.

Claimant had this land from Maka in 1847, Maka received it from Keilaloa in 1831, and held it in peace until he gave it to Kuleloailehua who now owns and Cultivates it.

Ana sworn, Knew these lands and confirmed the previous testimony.

### **1299 Hepa Sept 8[v. 2]**

Kaaha II sworn. This land is in ili of Paakea, Waititi, and consists only of 1 Kalo patch, bounded mauka by my land, Waimanalo by Nakani's, makai by Maha's, Ewa by Lailoa's. Claimant had this land from Kaaha 1<sup>st</sup> in 1846, and has ever since held it without any dispute.

Postpd for Kaaha 1<sup>st</sup>

Kaahai sworn and acknowledged the Gift as stated above and confirmed the testimony.

### **1302 Keau, Claimant [v 14/477]**

Claimant appeared and made oath that his claim was duly made out and presented by Kiko, the same is therefore admitted to a hearing.

Keaka sworn says he know the land of Claimant. It contains 2 Lois and a kula in one piece and a kahuahale in another, the land is in the ili of Kiki, Waikiki, and the house lot in Waiaka.

The land is bounded:

Mauka by the land of Kapawa, Kekaha by the Kahawai Pahoia, Makai by the land of Kapaakea, Honolulu by the land of Namaka.

Apana 2 the Kahuahale in Waiaka, is bounded: Mauka by the Pahale of Keawekaukeha, Kekaha by the Kahawai of Kalia, Makai by the Waiaka a kula, Honolulu by Waiaka a kula.

Claimant received the land form Kauaohima in the time of Kinau, and has held the same in quiet until the present time.

Kanepua sworn says the testimony above is true and his own is like it.

### **1303 Kukeanuenue Sept 11 [v 2 470]**

Kainikokoole sworn. This land I know, it is in Palolo mauka of Waititi (ahupua) in several pieces.



1 House lot. Mauka it is bounded by land called Kaululoa owned by a foreigner named Peter; Waialai side by Piihoi's; makai by Nakao's; Honolulu by my lands. It is not fenced, it has four houses, one is Claimants, one is mine, one Makua's, and the fourth Piliwale's. This lot includes eight Kalo patches. Claimant lives under me, I gave him the Kalo patches and the place on which his house stands, but not the ground on which the other 3 houses stand. I gave the land to Claimant in Kinau's time and received it a little before from Piikai.

This Witness being considered incompetent.

Nakau was enamed on oath; he stated this lot:

1 House lot, to be bounded mauka by land called Ululoa belonging to Peter; Waialai side by Pehu's lands; makai by Amala's lands; Honolulu by a bluff rock, the top of which is Pepoi's. (Neither this nor the former witness gave information definite enough to ascertain the true situation of this lot as to bounds or right.)

2 Five Kalo patches in one lot, bounded mauka by Lale's, Waialai also; makai by my lands; Honolulu by Kapali's land.

3 Three patches; mauka by Kekio's; Waialai also; makai by Nakau's; Ewa by Kapali's alnds. Kaiwikokeole gave Claimant these lots in time of Kinau, and he has ever since held them without any dispute. Piikoi is the Konohiki.

**Piikoi is the konohiki of Palolo.**

**1304 Keawekoloua Sept 11 [v 2 470]**

Kahuaina sworn. This land is in Wailupe, Waititi, Oahu, it is in one piece of part Kula and Kalo of 8 patches, it is not fenced, and has 1 house; bounded mauka by Uluoa's land, Waialai also and makai; Honolulu by a Pali.

Claimant had this land from Kamaha 4 years ago, who is the Konohiki under the King.

Kamaha's testimony wanted. See 475 pg.

**Kamaha is the konohiki of Wailupe.**

**1357 Kuahine Wahine Sept 22 [v 2 pg 497]**

Keaka sworn. This land is in the ili of Kiki, Waititi, in 3 pieces.

1 House lot;3 houses. 1 Claimants and 2 belonging to those who live under her. The yard is however divided, She occupies half, and they half. Kawea and my self live in the half adjoining Claimants half, and Pihoihoi is another who lives there. It is bounded mauka by Aea's kula land; Waialae by Luahinenui's; makai by Kahakai's; Honolulu by Kaaha's Kula land.

2 Kalo land, 1 patch. Mauka is Kahue's; Waialae Keau's; makai Kahakea's; Honolulu Lilikalane's.

3 One Kalo patch and privilege of planting in the auwai; mauka is Kahalehau's; Waialae by stream between it and Moku's; makai Nakai's; Honolulu Paukuwahie's.

Claimant had these lands from Paukuloahie who is Konohiki of them, in time of Boki and has ever since held them undisputed.

Kapaloaa sworn, confirmed all the above testimony.

**Paukuloahie is the Konohiki of Kiki.**

**1358 Kahue Sept 22 [v 2 pg 498]**

Puniai sworn. This land is in the ili of Kamokualua, Waititi, in two pieces:

1 House lot and 1 house, fenced with stone. Mauka is "Pahea"; Waialae Kaihe's land; makai also; Honolulu Kaaha's "Pahea".

2 Kalo land 3 patches. Mauka is Kululoailehua's; Waialae Onea's; makai Naimiemi's; Honolulu Peleule's.

Claimant had this land from Kaneuhi in time of Kamehameha II and has ever since held it undisputed to the present. Kuleloialehua is the Konohiki of it now.

Kapawaa sworn Confirmed the above.

**Kuleloialehua is konohiki of Kamokualua.**

**1359 Waipio Sept 22[v 2 pg 498]**

Kapu sworn. This land is in the ili of Kalaepohaku-lalo, Waititi, it is in one piece of two Kalo patches. Mauka is my land; Waialae also; makai and Ewa also. I gave this land to Claimant 4 to 5 years ago, and he has held it ever since undisputed, he does poalima work. I am Konohiki of it, under the King, and I know of the claimant to it but Waipio.

Waipio said. He claimed no more of land than other tenants; Kapu has been kind to him, but he did not claim this land as belonging to him absolutely.

**Kapu is konohiki of Kalaepohaku-lalo.**

**1360 Kapuniai Sept 22 [v 2 pg 498]**

Kapawa sworn. This land is in the ili of Kihi, Waititi, in 2 pieces:

1 House lot, one house and fence. Mauka is Kohakai's; Waialae Kaihi's; makai alao; Ewa Kaaha's "Pakea."

2 Kalo land, 1 patch: mauka is Paukuloahie's; Waialae Pakea's; makai Kukahiko's; Honolulu Lili's.

Claimant had the Kalo land from Pau Kuloahie in time of Kamehameha II, and has ever since held the same undisputed to this day. The house lot he had from his ancestors who have lived there from time immemorial.

Kahue sworn, Confirmed the testimony as above.

**1369 Kaukini Sept 25 [v 2 pg 502]**

Pahua sworn. This land is in Palama, ili of Kalipohaku, in one piece, Kalo and Kula with one house of Claimants and 3 Kalo patches with an auwai; bounded mauka by land of P. Kanoa's; Honolulu by Kapoe's; makai by Naluwai's and Ewa.

Claimant had this land from me in time of Kinau, about 10 years ago, and has never been disturbed. The land is Kekuanaoa's, Nalawai is Konohiki under him. I was luna under him at the time of the gift to Claimant.

**Nalawai is the konohiki of Palama.**

**1369 [1368?] Kaniniu Wahine Sept 25 [v 2 pg 502]**

Kaao sworn. I know this place, it is in Palama, ili of Kauamoa, in one piece of Kula and Kalo, number of patches not exactly known, there are 4 houses of Claimants; it is bounded mauka by Nalawai's land; Honolulu by Pi's; makai by Kaaumaa's; Ewa by Kealia's land and Huakine's land.

Claimant had this land from Keanuani in time of Kaomi, about 1835, and has held it undisputed to this time. Huahine is present Konohiki of Mose.

Kaimanu sworn, and confirmed the preceding testimony.

**1370 Kepaa Dec 13 [v 3/46]**

Koa sworn. I know this place, it is in Kalia, Waititi, consisting of a House lot having eight houses on it, two are belonging to Kauiki the Claimants father and an adopted father, the names of the other occupants I do not know, but they all live under Claimant on his land.

Kepaa only owns one house, it is enclosed by a fence except the Sea side. There are four Cocoa nut trees on the land, 3 belong to Claimant and one to Kamauholi.

Mauka is land of Kekuanaoa, Waialae Keohokalole, Makai Sea, Honolulu Kalaiheana.

Claimant had this place from Paku, in 1826. He is school head teacher. It was given to Claimant to occupy as teacher under him, this land was given unconditionally, but Claimant has another piece given him which is only to be held as long as he continues school teacher.

Pakee wanted (?-ends)

**1371 Pahua Sept 25 [v 2 pg 502]**

Kealiikule sworn. I know this land, it is in Palama ili of Kalaipohaku, in two pieces.

1 house lot in ili of Kawapuaa. Claimant has 1 house there bounded mauka by Nalowai's; Honolulu by Kuhinana's land; makai by Luluplieor's land; Ewa by Koakini's.

2 Kalo lands of 8 patches; bounded mauka by Kaukini's land, Honolulu by Kahapai'a; makai by my lands; Ewa by Nalawai's.

Claimant had this land from Nalowai in time of Kinau, he was Konohiki under Kekuanaoa, and held it undisputed to the present time.

Keliipuiaina swon, and confirms the entire evidence as above given.

**Nalowai was konohiki of Palama in Kinau's time.**

**1373 Kuekue Sept 29 [v 2 pg 506]**

Wailehua sworn. This land I know, it is in the ili of Pahupahuapuaa, Waititi, in two pieces.

1 One Kalo patch and auwai; mauka is Puhau's land; Waialae my land; makai Kalaimakali's; Honolulu Kekuapoe's.

2 Kula land; mauka is Napahi's; Waialae Keohokalole's; makai Hoolulu's; Honolulu Aahau's.

I gave Claimant this land in time of Kaahumanu 1<sup>st</sup> and he has held it ever since in peace. I am Konohiki of it, under Victoria and Claimant does poalima work when not acting as a soldier.

**Wailehua is konohiki of Pahupahupuaa.**

**1374 Kuheleloa Sept 25 [v 2 pg 503]**

Mahoe sworn. This place is in Pauwaa, Waititi, consisting of two lots.

1 House lot, with two Kalo patches, one house of Claimant bounded mauka by Ohuku's lands; Waialae Kuahai's; makai by Oopa's; Honolulu by Nawelo's.

2 Kalo land 6 patches; mauka is Kaielei's; Waialae Puanui's; makai Pohaku's; Honolulu by John li's.

Claimant had this land from John li in time of Kamehameha I. Kahakumakea is Claimant's wife, and She then received it when she had another husband. Claimant has been married to her about 3 years and puts in the claim for his wife. I know of no dispute ever having occurred about it to this time, John li is Konohiki of it, and Oopa under him. (Claimant said his wife wished the award in his name, the same as their claim and not in hers.) li confirms the above. 2 Nov 1849.

**John li is the konohiki of Pauwaa.**

**1376 Naoho Sept 27 [v 2 pg 458]**

Nalaweha sworn. I know this land, it is in the ili of Nukunuku and in Waititi, in two distinct pieces of 3 Kalo patches.

1 Two Kalo patches; mauka is my land; Waialae Kahaaheo's; makai Paukuahie's; Honolulu Wailehua's.

2 One Kalo patch; mauka is my land here under the King; Waialae Kaua's; makai my land; Honolulu Nahaikaua's.

Claimant had this land from me in time of Kaahumanu I and has ever since held it in peace without dispute. I am Konohiki of Nukunukuaua under Keloria.

**Nalaweha is the konohiki of Nukunukuaua.**

**1377 Malo Sept 29 [v 2 pg 506]**

Wailehua sworn. This land is a house lot in Wehewehe, Waititi Kai, fenced and has 1 house.

Mauka is Kekuaaoa's fish pond; Waialae my lands; makai is the sea beach; Honolulu Govt vacant land.

Claimant has this land from Kaluahinenui in time of Rihoriho, and has ever since held it in peace, he has gone and come without dispute.

**1378 Kawaihapai [v 2 pg 505]**

Nalaweha sworn. I know this land, it is in the ili of Nukunukuaua, Waititi, Oahu, in two pieces of 4 Kalo patches.

1 Three Kalo patches; mauka is Opio's lands; Waialae Kaaipua's; makai Nahaikaua's; Honolulu Opio's.

2 One Kalo patch, mauka Nahaikaua's; Waialae Govt land, Nahelehele; makai Kaleuleuli's; Honolulu Paupou's land.

Claimant had this land from me, Konohiki of it in time of Kaahumanu I, and has ever since held it without any dispute, he does poalima work except when required to act as soldier at the Fort.

**Nalaweha is the konohiki of Nukunukuaua.**

**1379 Kapule II Sept 29 [v 2 pg 506]**

Wailehua sworn. This land is in the ili of Auaukai, Waititi, Claimant has a house lot in the next ili of Keaumoku, of several pieces.

1 House lot, mauka is Auwa's land; Waialae Oku's; makai Kaelemakule's; Honolulu Govt land, Nahelehele. It is fenced and Claimant has a large and small house on it.

2 Two Kalo patches. Mauka is Keohokalole's; Waialae and makai also; Honolulu Peleule's.

3 Part of a Kalo patch; mauka is a large Kalo patch of many owners; Waialae Paku's; makai Keohokalole's; Honolulu Kaluahinenui's.

Claimant had this land from Kamaukole, lord of it in Kaahumanu 1<sup>st</sup> time, and has ever since held it without dispute, he does poalima work. Kamaukole is his Konohiki.

**Kamaukole is the konohiki of Auaukai.**

**1380 Kahaheo Sept 27 [v 2 pg 505]**

Nalaweha sworn. I know this land, it is in ili of Nukuhukuaua, Waititi, in 3 pieces of 3 Kalo patches.

- 3 One Kalo patch-mauka is Poupou's land; Waialae is Opio's; makai is my land; Honolulu Wailehua's.
- 4 One Kalo patch: mauka is Kaua's; Waialae is Kaaipua's; makai Opio's; Honolulu my land.
- 5 One Kalo patch-mauka Kaleuliuli's; Waialae Govt lands/waste; makai Kaaipua's; Honolulu Naoho's.

Claimant had this land from me in time of Kaahumanu 1, and has ever since held it in peace to the present time without any dispute. He does poalima work.

**1382 Nuuanu II Sept 29 [v 2 pg 506]**

Kapule II sworn. This land is in the ili of Auaukai, Waititi, in two pieces.

1 House lot, mauka is Kaluahinenui's Coconut Grove; Waialae Kalaulele's land; makai sea beach; Honolulu Opuhahao's. It is not fenced and has 1 house on it, there is a fence around this house and many others.

2 One Kalo patch; mauka is Kameheu's; Waialae Keohokalole's; makai Halue's; Honolulu is Kaelemakule's.

Claimant had this from Kamaukole, Konohiki of it in 1846 and has lived there in peace ever since.

Kamaukole wanted.

**Kamaukole is the konohiki of Auaukai.**

**1384 Paele Sept 27 [v 2 pg 505]**

Kehoaea's sworn. This land is in the ili of Pawaa, Waititi, consisting of a house lot, Kalo land, and some upland in 3 lots, there are 6 Kalo patches in all and 2 houses.

1 House lot fenced, including 4 Kalo patches; mauka is road to Waititi dividng it from Dr. Judd's; Waialae Kaluwahinenui's; makai Kaaua's; Honolulu Kapeau's.

2 One Kalo patch; mauka is Kaaooahana's; Waialae Paahea's; makai Kealiihuhu's; Honolulu Lilikalani's.

3 One Kalo patch, mauka is Kaaua's lands; Waialae Kaihiwa's; makai Kaaua's; Honolulu my lands.

Claimant had this land from Governor Kekuanaoa, in time of Kinau, and he has held it ever since without any dispute. I believe Kekuanaoa is his Konohiki, and his work is poalima, and to cultivate his lands.

John li sworn. Confirmed the above testimony.

**Kekuanaoa is the konohiki of Pawaa.**

**1385 Kaelemakui Oct 9 [v 3/9]**

Kokomo sworn. This place is in Auaukai, Waititi, it is kalo land consisting of:

1. House lot, fenced and Ce(?) owns one house on it, bounded Mauka by Kapule's lands; Waialae also; Makai by sea; Honolulu by Kuapaiea's.
2. One kalo patch. Mauka is Kapule's; Waialae is Nuuanu's; Makai is Nu's; Honolulu is Opuhaha's.
3. One row of kalo in a large patch, which is bounded as a whole. Mauka by Palupalu; Waialae by Pahu's (teacher); Makai by Kukealuaeu's; Honolulu by Kanai's (land).

Claimant has these lots from Kamaukule in time of Kaahumanu 1. Kamaukule was and is Konohiki under Kekaunaoa who owns the land, and has been held undisputed to the present time.

**NOTE: Kamaukule was/is konohiki of Auaukai, Keomuku (3<sup>rd</sup> konohiki for Keomuku?)**

**1386 Ainoa Oct. 6 [v 3/2]**

Kaukau sworn. This land is in the ili of Niukukahi, Waititi: it is in one piece of 3 kalo patches.

Bounded mauka and Waialae by my land; makai by Kekuanaoa's-"Kalia"- Honolulu by Kanaiana's.

Claimant has a house in another place but not a lot.

I gave him this land being Konohiki of it under the King-in about 1828. Kaahumanu's time, and he has ever since held it undisputed.

**NOTE- Kaukau was konohiki of Niukuhahi in 1828.**

**1387 Kawaihoe Oct 16 [v 3/3]**

Kauwai sworn. This land is in the ili of Kaluahole, Waititi. Kula and Kalo.

1. Kula land, bounded mauka by Kuakuia's, Waialae by Kawai's with a stream between, Makai by my land, Honolulu by Kawai's.
2. Kalo lands, 2 patches. Mauka is Kawai's, Waialae Kealiiielee's, Makai my lands, Honolulu Kawai's.
3. Small yard and house on the Sea beach.

Claimant had these lands from me in time of Kinau. I was then and am now Konohiki of this land under Kaipuaa. Claimant has held the same in peace without dispute to this time.

**Note: Kauwai is the konohiki of Kaluahole.**

**1388 Kahalehulihuli Oct 6 [v 3/3]**

Nalaeuaha sworn. This land is in the ili of Kanu-Kuaula, Waititi.

1. House lot having 1 house and fenced with ? in the ili of Keomuku, bounded mauka by Coconut patch of Keomuku; bounded mauka by coconut patch of Kuluwailehua. Waialae also; makai by the sea shore. Honolulu by Kalua-hinenuis.
2. 1 Kalo patch in Kanukuhaua. Mauka is lands of Koehapais; Waialae Govt-Kalo patch of bulrushes. Makai Kahaheo's; Honolulu Keloua's.
3. 1 Kalo patch, same ili. Mauka is Nahaikaua's; Waialae, Kaaipua's; Makai Kaua's. Honolulu Naoho's.

Claimant had these lands from me in time of Kaahumanu I. I was and am Konohiki of them under Victoria, and he has ever since held them undisputed. He does poalima work.

**NOTE: Nalaeuaha was/is konohiki for Keomuku in 1846.**

**1389 Keuapaia Oct 6 [v 3/3]**

Kuekue sworn. This land is in the ili of Keomuku, Waititi. Consisting of:

1. House lot. Mauka is Ka Elemakule's; Waialae and makai by the sea; Honolulu by Keaha's. Claimant has 1 house on it.
2. Kula lands-ili of Nohe. Mauka is Kaelemahule's. Waialae is Kaueheawa's; Makai Pahus; Honolulu is Puipui's.
3. Auwai Kalo. Mauka is Umi's; Waialae Kalawa's; Makai Puhau's; Honolulu Umi's.

Claimant has these lands from Kaahumanu 1 and has ever since held them undisputed, he is a sick man and does no poalima work which he would be liable for if well. Kekuaaoa is present Konohiki of this district.

**NOTE: Kekuaaoa is the konohiki for Keomuku. (why different than 1388 with claim that Nalaeuaha is the konohiki? Or is one district and the other smaller?)**

**1407 Kaeina Oct 11 [v 3/11]**

Nihopu sworn. This land is in the ili of Kamokuahahi, Waititi. It consists of 2 pieces:

1. House lot not entirely fenced. Mauka is land of Kekuaaoa's; Waialae Kukeele's; Makai my lands; Honolulu Kaele's; there are two houses on it. Claimant took it up waste, and has held it in peace since the time of Kaahumanu 1.



2. One kalo patch. Mauka is Kuluwailehua's; Waialae Kahaka's; Makai Omalo's; Honolulu Kuluwailehuas, from whom received this land before 1839, and has held it ever since in peace. Being sick he does no poahima work.

**1408 Kaula 1 Oct. 11 [v 3/11]**

Nalewaeha sworn. This land is in Keawamuku, Waititi, Oahu, in two lots.

1. House lot in Weawamuku; Mauka is Kaluawahinenui's; Makai and Honolulu also; Waialae is my house lot. It is fenced and has one house on it.
2. Kalo land in Kamokuaua, 2 patches. Mauka is Kahalehulihuli's; Waialae, Kaipua's; Makai, Kaelo's; Honolulu, my lands. I gave claimant these lands as Konohiki in time of Kaahumanu 1 and he has held them in peace, He does Friday work.

**NOTE: Nalewaeha as konohiki of Keawamuku.**

**1409 Nakoko Oct 11 [v 3/11]**

Kawao sworn. This land is in the ili of Aikahi, Waititi, Oahu, in two lots:

1. House lot. Kalia, partly fenced and one house on it. Mauka is Kehaunaoa's waste lands; Waialae is Paele's; Makai is Kaluahinenui's; Honolulu, Kimo's.
2. Kalo land in Aikahi two patches and an auwai. Mauka is Luikalane's; Waialae Kuluawilehua's; Makai Peleuli's; Honolulu, Kaluahinenui's.

I gave claimant these lands in time of Kaahumanu 1, and he has held them in peace ever since. I am Konohiki of them under Victoria.

**NOTE: Kawao was/is konohiki of Aikahi.**

**1410 Paele Oct 11 [v 3/11]**

Nihopu sworn. This land consists of a house lot in Kalia; and 3 Kalo patches in Kuilei, Waititi.

1. House lot, has one house and is not fenced. Mauka is Kekuanaoa's lands; Waialae Kaeina's; Makai by the sea beach; Honolulu Kawao's.
2. Three kalo patches together. Mauka is Naluua'a land; Waialae is Keolaloa's; Makai Namakeau's; Honolulu Keolaloa's.

Keolaloa gave these lands to claimant in time of Kaahumanu 1 and he has held them in peace ever since. Keolaloa is Konohiki under the King-he does poalima.

**NOTE: Keolaloa is konohiki of Kuilei (and Kalia?).**

**1411 Kuaana Oct 11 [v 3/11]**

Malo sworn. This land is in Kamoku, Waititi, Oahu, consisting of one kalo patch. Mauka is Kahiaweawe's land; Waialae is Kuluwailehua's; Makai Kuaikanue's; Honolulu my lands.

Claimant has this land from Kuluwailehua in about 1839, and has ever since held it undisputed. He did not, but now does poalima.

**1412 Malo Oct 11 [v 3/11]**

Anee sworn. I know this land in Wamoku, Waititi, in two lots of kalo lands.

1. Three patches. Mauka is Keauole's land; Waialae Keaka's; Makai Kuluwailehua's; Honolulu Kahiaweawe's.
2. Two patches. Mauka is Kuluwailehua's; Waialae Kahakai's; Makai Kalaeone's; Honolulu Pupule's.

Claimant has these lands from Kuluwailehua, his Konohiki, in time of Kinau about 1839, and has ever since held them in peace. He does poalima.

**NOTE: Kuluwailehua is konohiki for Kamoku.**

**1413 Kaula II W. Oct 11 [v 3/11]**

Malo sworn. This land is in the ili of Kamoku, Waititi, Oahu. Consisting of one lot in two kalo patches. Claimant's house is on Kuluwailehua's lands.

Mauka is Hiamoe's land; Waialae Kahakai's; Makai Haoole's; Honolulu, Mahoe's.

Claimant had these land from Kuluwailehua, her Konohiki in time of Kinau, about 1839, and has lived there in peace ever since.

**NOTE: Kuluwailehua was konohiki of Kamoku in 1839.**

**1414 Haole Oct 11 [v 3/11]**

Malo sworn. This land is in the ili of Kamoku, Waititi. Consisting of one kalo patch (his house is on Kuluwailehua's lands). Mauka is land of Kaula; Waialae Kahiaweawe's; Makai, my lands; Honolulu Kapulahi's.

Claimant had this lands from Kuluwailehua in about 1839, who is his Konohiki, and has ever since held it in peace and undisputed to the present times.

**NOTE: Kuluwailehua is konohiki in 1839 of Kamoku.**

**1415 Keaka Oct 13 [v 3/11]**

Malo sworn. This land is in Kamoku akahi, Waititi, one lot of 2 kalo patches; his house is on the seashore. It is bounded Mauka by Kahiaweawe's lands; Waialae by Kahakai's; Makai by Kuluwailehua's; Honolulu by my land.

Claimant had this land from Kuluwailehua in about 1839, he is his Konohiki, and he does poalima. He has ever since held the land undisturbed.

**NOTE: Kuluwailehua was konohiki of Kamoku akahi in 1839.**

**1416 Kuhaikanuu Oct 11 [v 3/11]**

Malo sworn. This land is in Kamoku akahi, Waititi, it is one kalo patch. He owns also a house lot in Pahea, Waititi.

1. House lot in Pahea. Mauka is waste lands; Waialae Kaaha's; and Makai, Honolulu, waste lands. Claimant has 3 houses on it, and it is partly fenced.
2. Kalo land, 1 patch. Mauka is Kaaha's; Waialae Kamuli's; Makai Kuluwailehua's; Honolulu, Mahoe's.

Claimant has these lands from Kaaha about 1839 for time of Kinau, and has ever since held them in peace. Kaaha is his Konohiki and he does poalima work.

**NOTE: Kaaha is the konohiki for Kamoku akahi or Pahea?**

**1417 Kuaana 2 Oct 13 [v 3/11]**

Malo sworn. This land is in Kamoku elua, Waititi. It is one lot of 6 kalo patches, one of them planted and the rest grown over with rushes. Mauka is Anee's land; Waialae, Mahoe's; Makai Lahilahi's; Honolulu, Pupule's. Claimant had this land in time of Kinau, about 1839 from Kuluwailehua, who is his Konohiki, and he does poalima. He has ever since the gift held it undisputed.

**NOTE: Kuluwailehua is konohiki of Kamoku elua.**

**1418 Mahoe We. Oct 13 [v 3/11]**

Malo sworn. This land is in Kamoku elua, Waititi, in two pieces of kalo land.

1. Two kalo patches. Mauka is Kuluwailehua's lands; Waialae Kuaa II; Makai Kapulani's; Honolulu, Nahai's.
2. One kalo patch. Mauka is my land; Waialae is Kuaana's; Makai Kuluwailehua's; Honolulu Kuaana II.

Claimant had these lands from Kuluwailehua years ago, and has ever since held them in peace.

Posted for Kuluwailehua's test.

**1419 Kamaha Oct 13 [v 3/11]**

Kaohao sworn. This land is in Niukukahi, Waititi. Consisting of several pieces.

1. Kula lands. Mauka is Kamauhole's; Waialae Kuluwailehua's; Makai my land; Honolulu Kauaina's. There is one house on it.
2. Kalo lands; 3 patches and some auwai's. Mauka is Maikona's; and Makai, Waialae, Haumea's; Honolulu, Kanaina's. Claimant had these lands from me, when I was Konohiki of them in 1838, and am now, and he has ever since held them in peace. He does poalima work.

**NOTE: Kaohao was/is konohiki for Niukukahi.**

**1420 Kahiaweawe Oct 13 [v 3/11]**

Malo, sworn. This land is in Kamoku akahi, Waititi, in 3 pieces, 2 only are planted.

1. Mauka Kalo Patch (one), Mauka is land of Kaua 2; Waialae Kahakai's, Makai Keakas; Honolulu Anee's.
2. One Kalo Patch (makai ahu) Mauka is Anee's; Waialae and Honolulu is my lands; Makai Kuaana's
3. One Kalo Patch (makai loa) Mauka is Kuluwai, Lehua's and Makai (Kalia), Waialae Kahakai's, Honolulu, my lands.

Claimant had these lands about 1829 in Kinau's time, from Kuluwailehua, who is his Konohiki. He does poalima, and has always held the lands in peace to the present time.

**NOTE: Kuluwailehua is the konohiki of Kamoku aKahi.**

**1421 Kao Oct 13 [v 3/11]**

Kaohao sworn. This land is in Niukukahi, Waititi, in 3 pieces.

1. Kula land, Mauka is Kamauhole's, Waialae and Makai Kuluwailehua's, Honolulu Paukuwahie's.
2. Kalo land, 2 patches. Mauka is my land, Waialae Makahonu's, Makai Kanaina's, Honolulu Paukeewahie's.
3. One Kalo Patch. Mauka is Pake's, Waialae is Makahonu's; Makai Amae's; Honolulu Kalaniokee's.

Claimant had these lands from me, his Konohiki, in 1838 in Kinau's time, and he has held them ever since in peace, he does poalima.

**NOTE: Kaohao is the konohiki of Niukukahi.**

**1422 Kaalooa Oct 13 [v 3/11]**

Hoopuia sworn. This land is in MauluKiKehe, Waititi, in two pieces.

1. Kula lands-Mauka and Honolulu is my land, Waialae Kanaina's; Makai Keolulooa's.

2. One Kalo Patch and an auwai. Mauka is Kuluwaluhua's, Waialae Kupa's, Makai my land, Honolulu Kaaha's.

Claimant had these lands from me his Konohiki in 1821. When Mr. Bingham left the Islands, and he has ever since held them in peace. He does poalima work.

**Note: Hoopuia is konohiki of Maulukikehe.**

#### **1423 Kahalehau Oct 13 [v 3/11]**

Uma sworn. This land is in Kiokapu, Waititi, in 3 pieces of Kalo lands.

1. Two Kalo patches together. Mauka piece: Mauka is Kaihi's lands, Waialae John Youngs; Makai Paukuwahie's, Honolulu Aea's.
2. One Kalo Patch. Mauka is Kaihi's, Waialae Kapahi's, Makai Kauhane's, Honolulu my lands.
3. One Kalo Patch (makai). Mauka and Waialae is my lands, and Honolulu, Makai is Kekanaoa's. Claimant has a house on this lot.

Claimant had the first land from Kauai in 1835, he had the second lot from Kopusia in 1837. This piece is in Maulukikepa; he had the third piece from Kaah in Kaomi's time about 1834, and has held them all in peace ever since.

#### **1424 Kaniuhi Oct 13 [v 3/11]**

Kopusia sworn. This land is in Pakea, Waititi in two distinct pieces.

1. One Kalo Patch. Mauka and Waialae is Moho's lands; Makai and Honolulu, Kaaha's.
2. One Auwai. Mauka is Kipi's, Walalae and Makai Kaaha's, Honolulu Poai's.

Claimant had these lots from Kaaha his Konohiki in Kinau's time, about 1838, and has held them in peace since.

**Note: Kaaha is konohiki of Pakea.**

#### **1425 Kauhao Oct 13 [v 3/11]**

Ainoa sworn. These lands are in Niukukahi, Waititi, in 2 distinct pieces.

1. Kula lands. Mauka is Kamauhole's; Waialae Kuluwailehua's, Makai Kaluahinenui's, Honolulu Kanaina's.
2. Kalo Lands, 5 patches and 2 Auwais. Mauka and Makai is Kaluahinenui's land, Pahie, Waialae Keaumea's, Honolulu Kanaina's. There are 3 houses on this lot.
3. Six Kalo Patches and 1 Auwai. Mauka and Makai is "Kalia", Waialae Kekuanaoa's, Honolulu Kanaina's.

Claimant has these lands from Kamehameha and in Kaahumanu 1 time and has ever held them in peace.

Kapu sworn. I heard the King gave this land to claimant in time of Kaahumanu 1, but I know nothing about the boundaries.

**1426 Koa Oct 13 [v 3/11]**

Keahiehia sworn. This land is in Moomuku, Waititi, in two pieces.

1. Kalo land, 3 patches. Mauka is Kauhao's, Waialae Kukahiho's, Makai A. Adams, Honolulu, Makahonu's.
2. Two Kalo patches. Mauka and Waialae by Kahuika's, Makai by Napahi's, Honolulu Kahuika's.

Claimant received the 1<sup>st</sup> piece (3 patches) from Makahonu, Konohiki of these lands in time of Kinau about 1838. He has the second piece from Kahaka near the same time. Claimant is a teacher and has ever since held these lands in peace.

**NOTE: Makahonu is konohiki of Moomuku.**

**1427 Lukahili (?-unclear) Oct 13 [v 3/11]**

Malo sworn. This land is in Kamoku elua, Waititi, in 3 pieces.

1. One Kalo patch. Mauka is Pupule's, Waialae is Kukuwailehua's, Makai Nahau's, Honolulu Namimi's.
2. One Kalo patch. Mauka is Mahoe's, Waialae and Honolulu is Anee's, Makai my lands.
3. One Kalo patch. Mauka is Mahoe's land, Waialae is Kuluwailehua's, Makai Kaluahinane's, Honolulu Kuaana's.

Claimant received this land from Kuluwailehua in 1822 and possesses it ever since in peace.

Post for Kuluwailehua's des.

**1428 Maikona Oct 16 [v 3/11]**

Kauhao sworn. These lands are in Niukakahi, Waititi; Kula and Kalo.

1. Kula lands. Mauka is Maukole's land, Waialae Kuluwailehua's, Makai Kaluahinenui's, Kalia-Honolulu, Kanaina's.
2. Kalo land 1 patch. Mauka and Makai is Kaluahinenui's, (Kalia) Waialae Haumea's; Honolulu Kanaina's.
3. One Kalo Patch and an auwai. Mauka is land of mine, Waialae Hoamea's, Makai Makole's, Honolulu Kanaina's.

Claimant had these lands from me in 1839 or thereabouts. When Kinau was in power, and has ever since held them undisputed. I am Konohiki of them.

**Note: Kauhao is the konohiki of Niukakahi.**

**1431 Uma Oct 16 [v 3/11]**

Puniau sworn. This land is in Kamoku elua, Waititi. Kula and Kalo.

1. House lot and 7 Kalo patches in one lot. Mauka is Palaualelo's lands, Waialae Kauhana's, Makai Kekuanaoa's, Honolulu Kaluahinenui's.
2. One Kalo patch. Mauka, Waialae and Makai by Kuluwailehua's lands, Honolulu is Kapopo's.
3. One Kalo patch. Mauka and Honolulu is Kuluwailehua's lands, Waialae and Makai is Namimi's.

Claimant had these lands from Kaneuhi about 1832, in Kaomi's time, and has ever since held it in peace and eaten its food. He does Poalima and Kuluwailehua is his Konohiki.

**Note: Kuluwailehua is the konohiki of Kamoku elua.**

**1432 Naheana Oct 16 [v 3/11]**

Uma sworn. This land is in Kamoku elua, Waititi, in two lots of Kula lands.

1. Two Kalo patches in one lot, bounded on all sides by Kuluwailehua's land.
2. One Kalo Patch. Mauka and Honolulu is land of Pupule, Waialae Kalaioni's, Makai Kuluwailehua's.

Claimant had this land from Kaneuhi about 1834, when there was great trouble, and has ever since held it in peace.

**1433 Kaluhi Oct 16 [v 3/11]**

Kauhao sworn. This land is in Niukukahi, Waititi, the Kalo, his house lot is in Keamohamo, Waititi.

1. Four Kalo patches and an auwai together. Mauka is Kamakahonu's lands, Waialae Puhau's, Makai and Honolulu Kamakahonu's.
2. House lot and Kula. Mauka is Kamaukole's, Waialae Kuluwailehua's, Makai Kaluahinenui's, Honolulu Kamakahonu's.

I gave these lands to Claimant in time of Kaahumanu 1 and he has held them undisputed ever since. He does poalima. I am his Konohiki.

**Note: Kauhao is the konohiki of Niukukahi.**

**1434 Kealakai Oct 16 [v 3/11]**

Kauhao sworn. This land is in Kamohamo, Waititi. Some of it in Papupahuapuaa.

1. Kula lands and 1 Kalo Patch in the latter. Mauka is Napahi's, and Waialae and Makai also. Honolulu Kamakahonu's.

2. Kula in the same place. Mauka and Waialae is land of Napahi, Makai Kekukahiko's, Honolulu my lands.
3. House lot in Kamohamo. Mauka and Waialae is Kanealoe's, Makai Keohokalole's, Honolulu Waipuaa's.

Claimant had these lands from Kahuika in 1844, and has held them ever since in peace.

Postponed for Kahiuka.

**1435 Anee Oct 16 [v 3/11]**

Nahau sworn. This land is in Kamohuelua, Waititi. Consisting of 6 Kalo Patches, in one piece.

Makai is my land, Waialae Malo's, Mahai is Malo's, Honolulu Peleuli's.

Claimant had this land from the Konohiki Kuluwailehua in Kinau's time about 1838, and has ever since held it in peace. He does poalima.

**Note: Kuluwailehua was the konohiki of Kamohuelua.**

**1437 Kaohulenui Oct 16 [v 3/11]**

Kauhao sworn. These lands are in the ilis of Pahupahuapuaa akahi and Kamohamo, Waititi, in 3 pieces.

1. House lot in Kamohamo. Mauka and Waialae is Kanealoe's land, Makai Kamauhole's "Auaukai", Honolulu Kaluahinenui's (Kalua).
2. Kula in Pahupahuapuaa. Mauka is Napahi's, Waialae and Honolulu Kuluwailehua's, Makai is "Kalia".
3. Kalo land 3 Patches and an auwai in the same ili. Mauka is "Kalia", Waialae Mahuka's, Makai Kuluwailehua's, Honolulu Napahi's.

Claimant had these lands from Kahiuka his Konohiki in time of Kaahumanu 1, and has ever since held them in peace. He does poalima.

**1438 Ku Dec 13 [v 3/46]**

Kahanaumaikai sworn. I know this land, it is in Mooiki, Waititi. Consisting of 4 Kalo patches in one lot. No house or fence. Mauka is my land, Waialae Koa, Makai my land, Honolulu, Paki.

Claimant had this land from Kanemakua, Konohiki when he gave it in 1827 time of Boki, but not at present. Kamakahonu is present Konohiki. Ku has cultivated them ever since he received them, and held them undisputed except a threat of Kamakahonu 4 years ago to take one patch away.

Kailikoa sworn. Confirmed the testimony as given above.

**Note: Kanemakua was konohiki of Mooiki in 1827, now Kamakahonu is konohiki.**



**1439 Kailiwai We [wahine] Oct 16 [v 3/11]**

Puele sworn. This land is in Kaluaokau, Waititi. Kalo and Kula, and Claimant has a house in too fence.

1. One Kalo patch. Mauka, Waialae and Makai is "Kalia". Honolulu Kalamoku's.
2. One Kalo patch, bounded the same as the first.
3. One Kalo patch and Kula, bounded the same as the others.

Claimant had these lands from her mother Kaiole in 1825, who had just got it from Kanaina who is Konohiki of it. She has ever since held it in peace.

**Note: Kanaina is the konohiki of Kaluaokau.**

**1443 Kahanaumaikai Dec 13 [v 3/46]**

Ku sworn. This place is in Mooiki, Waititi, consisting of several pieces of Kalo lands.

1. First one Kalo patch. Mauka is Kanemakua's land, Waialae is Koa's, Makai my land, Honolulu Pahi's.
2. One Patch. Mauka my land, Waiale Koa's, Maikai Keawelaikine's, Honolulu Paki's.
3. One Patch. Makai Kaiakoili, Mauka is Kanemakua's, Waialae is Kauhao, Honolulu is Paki's.

Claimant had these patches from Kanemakua in time of Boki around 1827, and has held them without dispute ever since and cultivated them.

Pailikoa sworn and Confirmed the testimony as true now given.

**1450 Koa Dec 13 [v 3/46]**

Kuolulu sworn. I know this land, it is in Kamohamo, Waititi. Consisting of Kalo land 2 Patches in one lot, and a house lot separate with two houses of Koa's and a fence.

1. House lot. Mauka is Kaniho's, Waialae Kekuanaoa's, Makai by Sea, Honolulu Kehauonohi.
2. Kalo land. Mauka is Kulewailehua's, Waialae is Kekauonohi's, Makai Keakuonohi's, Honolulu Kepaa's.

Claimant had these two lots from his elder Brother Helekalule who died in 1842 when he left them to Claimant by will, and he has held them ever since undisputed, his brother held them a long time before.

Kepaa sworn. Confirmed the preceding account as true.

**1452 Kaau Dec 15 [v 3/46]**

Kanahaole sworn. I know this place, it is in Hamohamo, Waititi. Consisting of Kalo and Kula land in five lots.

1. House lot having one house belonging to Claimant and no fence. Mauka is Keohokalole's land, Waialae is Kaneloa's, Makai is Kaia's, Honolulu Kalu?
2. Second lot, one Kalo patch. Mauka is Kaumaka's, Waialae is Kapea's, Makai is Ehu's, Honolulu is Hokaua's.

Claimant had both these lots from Keohokalole in 1845 and has ever since held them undisputed. Keohokalole is Konohiki of Hamohamo, and Claimant received the land from him as a man under his rule.

Beretane sworn. Confirmed the testimony as above given. The witnesses after stated that Claimant had these lots direct from HOOKAIA is under Konohiki.

HOOKAIA wanted (?-ends)

**Note: Keohokaloe is konohiki of Hamohamo, HOOKAIA is under konohiki.**

#### **1453 Kamaole (Manaole) Dec 15 [v 3/46]**

Kaohe sworn. I know this place it is in Kanuhuaula in Waititi, and the house lot in Hamohamo.

1. Kalo land of 2 patches, 3 streams, some Kula in Kanukuaua. Mauka is land of Pakee, Waialae is Mahuka, Makai is HOOKAIEE's, Honolulu Kaluahinenui.
2. House lot, Mauka is Kaanaanaa, Waialae Kealuelele's, Makai my lands, Honolulu Naa's.

Claimant has one house on this lot but no fence. He had the last lot #2 from Kikauaha about the time of the Kauai War (1823) and has held it undisputed ever since. Claimant had the 1<sup>st</sup> lot from Nalawehea at the same time, and has never been disturbed in his possession of either. He cultivated the land to this day.

Kuhewa sworn Confirms the Testimony of Kaohe as above.

This claimant says his name is Manaole, his claim is signed as above H. He did not write it and says it is an error.

#### **1454 Kaohe Dec 15 [v 3/46]**

Kuhewa sworn. I know this place, it is in Mookai, Waititi. Consisting of Kalo and Kula and a house lot in Hamohamo, both in Waititi.

1. House lot Hamohamo. Mauka is Manaole's, Waialae is Kinikini's, Makai is Mokulehua's, Honolulu Naa's.
2. Kalo patches 2 in one lot in Moohai. Mauka is Kaluahinenui, Waialae is Uma's, Makai is Kuluwailehua's, Honolulu is Wm. Sumer's.
3. Two Auawis or streams. Mauka is Pupuha's, Waialae Palaualelo's, Makai Pelewale's, Honolulu Kimo's.
4. Kula land. Mauka is Waiauhio's, Waialae Kahalehau's, Makai Uma's, Honolulu is Kaluahinenui's.

Claimant took up the first lot in Hamohamo in time of Kaahumanu 1 and has lived on it and held it ever since undisputed. He had two houses on it but no fence. Hoohaia is Konohiki .

Claimant had all the pieces under #2 in Moohai from Palaualelo in time of Kaahumanu. He is an old man still living as Konohiki of the land, and has ever since held these lands undisputed.

Manaole sworn Confirmed the previous testimony.

**Kaohe is konohiki of Mookai.**

**1455 Pelekane Dec 15 [v 3/46]**

Iwinui sworn. I know this land, it is in Hamohamo, Waititi. Kula and Kalo land separate.

1. Consisting of two parches (one house fenced (#3) and Kula land.) Mauka is Kapea's, Waialae is Hookeia's, Makai also, and Honolulu.
2. Kula lot. Mauka is Kahanamaikai, Waialae is Kaluahinenui's, Makai Napahi', Honolulu is Kuluwailehua's. Cultivated but not built upon or fenced.
3. House lot, one house fenced. Mauka is Hoohaio's, Waialae Kahula's, Makai Pelawale's, Honolulu Kapea's.

Claimant had all these lots from Kaohaia in time of Kaahumanu, and has lived there ever since cultivating them to this time without any opposition, and in peace.

Kapea sworn Confirmed the testimony as now given.

**1456 Iwinui Dec 15 [v 3/46]**

Pelekane sworn. I know this land it is in Hamohamo, Kula and Kalo. House lot in Kekio.

1. House lot in Kekio. Mauka is Kihewa's, Waialae is Koa's Makai Kealueleele's, Honolulu Kaumaka's.
2. One Kalo patch in Hamohamo. Mauka Koolau's, Waialae Halehuki's, Makai Kaolulo's, Honolulu Kukealiiiaiu's.
3. Kula ground. Mauka Kahanaumaikai's, Waialae Kaluhinenui's, Makai Napahi's, Honolulu is Kuluwailehua's.

Claimant had all these lands from Koohaia in time of Kaahumanu 1, and has held and cultivated them ever since without any dispute.

Kapua sworn Confirmed the above testimony as true.

**1457 Paumano Dec 15 [v 3/46]**

Pelekane sworn. Paumano died lately and left all his rights to his wife Kaumaha, who has been his wife since Kaahumanu's time. They have no children, and the land was hers at first.

The Claimants land is in Hamohamo Waititi, consisting of Kalo and Kula and 1 house lot.

1. House lot. Mauka is Hohopa's, Waialae is Iwinui's, Makai is Kawaaulu's, Honolulu Ua's. One house is on this lot in which Claimant lives, it is fenced
2. Kalo land, two patches and 1 auwai or stream. Mauka is Manaole's, Waialae Kahue's, Makai is Kaau's, Honolulu Koa's.
3. Kula land cultivated formerly. Mauka is Kahanaumakai's, Waialae is Kaluahinenui's, Makai is Napahi's, Honolulu Kuluwailehua's.

Claimant had these lands from Aikanaka a high chief, in time of Kuahini before 1821, and has ever since held them undisputed. They have been long in the descent of family rights.

Kapea sworn Confirmed the testimony given.

#### **1458 Kapea Dec 18 [v 3/46]**

Kaanana sworn. I know this place, it is in Hamohamo, Waititi, in several lots.

1. House lot, having 2 houses, 1 Claimant, 1 Paikanes (this last is a separate claim and accordingly detached in this statement of boundaries). Claimant has one house and it is fenced. Mauka is Kekuanaoa, Waialae is Kekauonohi (Paikane), Makai Keohokalola, Honolulu Kekuanaoa.
2. One Kalo patch. Mauka is Kaumaka, Waialae Kahula, Makai Kehakalole, Honolulu Kaau.
3. Kula. Mauka W. Sumner, Waialae Kekuanaoa's, Makai also and Honolulu.

Claimant had all these lands from Naihe high chief in time of Kaahumanu 1, and has held them to the present day and cultivated them without dispute. Keohokalole is the Konohiki of the land.

Paikano sworn, and confirmed the above.

(There are two houses and two persons in one fence, the present claimant and Pelekane. See Cr. 1455, the boundaries are separately stated in both claims in the Testimony).

**Keohokalole is the konohiki of Hamohamo.**

#### **1459 Kuihewa Dec 18 [v 3/46]**

Kaihukaa sworn. This land is in Mookai Waititi, in Kalo and Kula.

1. House lot. Claimant has two houses on it and fence. Mauka is Kekuanaoa's, Waialae Keohokalole's, Makai and Honolulu Kekuanaoa.
2. Two Kula patches and auwai. Mauka Kekahuna's, Waialae Kukui's, Makai Kuaane, Honolulu is Kanemakua.

Claimant had these two lots from Palace Konohiki, in time of Kaahumanu 1 and has ever since held and cultivated them in peace, there is no counter claimant.

Kaanana sworn and confirmed the testimony as above.

**Palace was the konohiki of Mookai.**

**1462 Kuewa Dec 18 [v 3/46]**

Kaohe sworn. I know this land, it is in Mookai, Waititi, Kula and Kalo.

1. House lot. Claimant has 1 house on it unfenced. Mauka is my land, Waialae Kahue, Makaia Sea, Honolulu Pupuka. This is in Hamohamo.
2. One Kalo patch and part of a stream or auwai. Mauka is Kemalo's land, Waialae Maka, Honolulu Kauai's, Makai Pupuka's.
3. One Kalo patch and part of auwai. Mauka is Hulikau's, Waialae Kauhao's, Makai is Palauolelo's, Honolulu Kaakai's.

Claimant had these lands from Palauolelo (Konohiki then and now) in time of Kaahumanu and has ever since held and improved them undisputed to this time.

Kuihewa sworn and Confirmed the testimony as it is given above.

**Palauolelo is the konohiki of Mookai.**

**1463 Wahahie Dec 18 [v 3/46]**

Opio sworn. I know this land, it is in Waititi, district of Kaluakau and Kanukuaua. Consisting of Kalo and Kula, and a house lot in Helumoa.

1. House lot. Claimant has one house and it is fenced. Mauka is Kekuanaoa's, Waialae also, Makai Kuluwailehua's, Honolulu Kekuanaoa.
2. Kaluakau, two Kalo patches. Mauka is Male's, Waialae Palupalu's, Makai Kekuhuna's, Honolulu is Kauapuni's.
3. Kanukuaua, One Kalo patch and auwai. Mauka is Kuahaia's, Waialae Kawai's, Makai is Nahoo's, Honolulu Kaaeo's.
4. One Kalo patch. Mauka is Kaeo's, Waialae Kaaipua's, Makai is Govt. Kalo patch, Honolulu is Naoho's.

Claimant had the house lot No 1 from Kulaiheana in time of Kaahumanu 1, and has ever since lived in it without any dispute. He had No 2, Kalo patches, from Pakanaka same time as No 1, and has held it in peace also. He had No 3 and 4 from Nalaweha, Konohiki, about 1945 and has never been disturbed in the right.

Kahiuka sworn and confirmed the above testimony.

Nalaweha wanted (? Ends)

**Nalaweha is the konohiki of Kaluakau/Kanukuaua.**

**1464 Umiumi Dec 20 [v 3/46]**

Pulehu sworn. I know this land, in Waiaala, Waititi, consisting of Kalo and Kula land.

1. Kalo, 1 Patch and 2 uncultivated. Mauka A. Adams, Waialae Kaanana, Makai Adams, Honolulu my land.
2. House lot in Helumoa, having two houses, 1 Claimants and one Kaananas (if appeared on inquiry that those are two distinct lots) that of Umiumi having one house on it is bounded Mauka by Govt. road, Waialae Kaamana's, Makai Kanemakua, Honolulu Kalaiheana. It is fenced round but not between this and Kaanana's.

Claimant had this lot from Kanemakua in Boki's time about 1830, and had ever since held it undisputed. The first lot he got from Kahue after Kinau's death and has ever since held it in peace. Kahua had it from A. Adams and was Konohiki. He is now settled at Kauai.

Kaua sworn, and Confirmed the above account.

Kanemakua and Adams wanted(...?ends)

**Note: Kahua was konohiki of Waiaala.**

#### **1465 Pulehu Dec 20 [v 3/46]**

Umiumi sworn. I know this land, it is in Waiaala, Waititi. Kalo land two patches, bounded Mauka by Mahahonu, Waialae Kaaea, Makai Kuluhinenui, Honolulu Keohokahina.

Claimant had this land from Kahue, Konohiki after the death of Kinau about 1820, and has held it without dispute ever since. Claimant is living under A. Adams who is Konohiki of the district.

Kaua sworn and Confirmed the above testimony.

Adams wanted (...?ends)

**Note: Kahue was konohiki of Waiaala, now Adams is konohiki.**

#### **1466 Kaunana Dec 20 [v 3/46]**

Pulehu sworn. This land is in Helumoa, Waititi, and in Waiaala, Kula and Kalo.

1. House lot in Helumoa. He has 1 house on it, fenced. Mauka Govt road, Waialae a stream, Makai Sea, Honolulu Umiumi's.
2. Kalo land, 1 Patch and 2 uncultivated. Mauka is Wailehua's, Waialae Paele, Makai Adams, Honolulu Umiumi.

Claimant had the house lot from Kanemakua in time of Boki, and the Kalo land No 2 from Kahue after the death of Kinau, about a year after. Claimant has never been disturbed in the possession of these two lots.

Umiumi sworn and Confirmed the above testimony.

Wanted Kaheihaha (?) and Adams

**1467 Kikooo Dec 20 [v 3/46]**

Kaumoali sworn. I know this land, it is in Kaneloa, Waititi. Kalo and Kula and Kapahulu.

1. House lot in Kapahulu, Waititi. Claimant has two houses, no fence. Mauka is Kaniho's land, Waialae (this lot is included in the boundaries given in Claim 1449 Witnesses land). I gave Claimant this land when G. Paulet was here, I did not give any land, but the use of enough to build a house upon to have as long as he might live. It has no inner fence.  
Kapilimanu sworn and stated the account to be correct which Kaumoali has given.
2. Kalo land in Kaneloa, 3 Patches. Mauka is Kaniho's, Waialae Mahuka, Makai Pehu, Honolulu Keohokalole.
3. One Kalo Patch. Mauka is Kaniho, Waialae Mahuka, Makai Pehu, Honolulu Koaulu.

Claimant had this from Kanehanaiakeakua, in time Kaahumanu 1, and has ever since held it in peace.

Kaumoali sworn Confirmed the above account.

**Note: Kaumoali was konohiki of Kaneloa.**

**1468 Kaiahopuwale Dec 20 [v 3/46]**

Kapilimanu sworn. I know this land, it is in Waititi in Pahupahupuaa. Kalo and Kula, 1 house lot in Hamohamo.

1. House lot. Claimant has one house fenced. Mauka Keohokalole, Waialae Kauohilo's, Makai Govt. road, Honolulu Kihewa's.
2. One Kalo Patch. Mauka is Napahi's, Waiale is Kekuapohe, Makai Keahuakahiko, Honolulu Kaluhi's.

Claimant had the 1<sup>st</sup> (house lot) from Kuahuia in time of Kinau before 1839, and has never been disturbed in the possession of it. Kuahuia is dead, he was under Keohokalole, Loho is now head chief of the land. Claimant had the 2 lot (Kalo), from Kaulahiliea, former Konohiki, in Kaahumanu 1 time, and has never been troubled in the possession of it to this time.

Kikooo sworn and Confirmed the account given as stated above.

**Note: Kuahuia was konohiki of Pahupahupuaa. Loho is now 'head chief of the land.'**

**1500 S (?) Dec 29 [v 3/74]**

Haole sworn. I know this place, it is in Makiki and Waititi.

1. Seven Kalo Patches in Makiki. Mauka is Kekauliohamoa, Waialae J.S., makai KaulioKamoa, and Ewa.
2. Four Salt Ponds Waititi. Mauka Kauhi's, Waialae Kane's, makai Kahelelua, Honolulu sea channel.

Kaukiokamoa gave the first lot to Claimant in 1844, and Kauhi have the second in 1846, and has held them in Peace.

Refer to Kauliakamoa and Kauhi.

**1503 Puaa Dec 29 [v 3/73]**

Pahiha sworn. I know this land, it is in Kukuluaeo, Waititi, consisting of:

1. One Fish pond. Mauka Govt Kula land, Makai Keo, Waialae Kekuanaoa, Honolulu a stream.
2. Two Fish ponds. Mauka is Govt Kula, Waialae Paele, Makai Puula, Honolulu Kumukau.

Kauhi gave these lots to Claimant in 1847. He got them from Mr. Armstong the same year.

Refer to Mr. Armstong.

**1506 Waikiki (W)(Wahine) Dec 27 [v 3/67]**

Kanai sworn. I know this land, it is in Hohe, Waititi, consisting of Kalo land, and in Uluho of House lot.

1. House lot. Claimant has 1 house partly fenced. Mauka is Govt land, Waialae is Opuhahoa, Makai Sea, Honolulu is Keawe.
2. Two rows of Kalo in a large patch owned by many. Mauka is my Kalo ground, Waialae is Pahu, Makai is my land separated by Water Course, Honolulu kaluahinenui.

Claimant had these two lots from Kaahumanu 1 and then held them from Kinau and now under Victoria, and never had them disputed.

Second witness (...?ends)

**1507 Kaleimakalu Dec 27 [v 3/67]**

Wailehua sworn. I know this place, it is in Waititi, in Pahupahuapuaa. Consisting of:

1. Kula land, Govt fence. Mauka is Holulu, Waialae Keohokalole, Makai by my land, Honolulu is Kaehuka.
2. One Kalo Patch. Mauks Kuhui, Waialae is my place, Makai Hoolulu, Honolulu Kekuapoi.
3. One Kalo Patch. Mauka my place, Waialae is Paupau, Makai Kekuanaoa, Honolulu Kekuapoi.

Kaahumanu 1 gave these 3 lots to Claimant who had held them ever since in peace, and holds them now under Victoria.

1. House lot in Waititi Kai. Mauka Popoki, Waialae Kapule, Makai Kaina, Honolulu Kauhau. Claimant has 1 house, partly fenced.
2. Kalo, 2 Patches. Mauka Kaleimakalii, Waialae my land, Makai Kamaukole, Honolulu Kekuiapoi.
3. Kula and a Kalo Stream in part. Mauka is Kukui, Waialae Keohokalole, Makai Kaleimakalii, Honolulu Kekuanaoa.

Kaahumanu 1 gave all these lots to Claimant now hold them under me as agent for Victoria.

**1509 Maikaloa Oct 16 [v 3/11]**

Kukue sworn. This land is in Kamoku akahi and Hohe, Waititi.

1. House lot, without house or fence. Mauka and Waialae and all sides bounded by Kakahiko's land.
2. Kalo land 2 Patches. Mauka is a stream, Waialae Kamoku, Makai stream, and Honolulu.

Kamoku Konohiki gave Claimant these lots in time of Kamehameha 1, and he has held them undisputed ever since.

Kawelo sworn and Confirmed the same.

Umu sworn. This place is in Kaalawai, Waititi, consisting only of a house lot, with 2 houses of Claimant and an imperfect fence. Mauka and all sides bounded by Kukahiko, present Konohiki who gave it to Claimant in time of Kamehameha 1, and he has ever since held it undisputed to the present time.

**1727 Niau [v 3/173]**

Lehuanui. This is in Kanewai, Waititi in two kalo lots.

1. 1 patch. Mauka my land, Waialae Kawelo, Makai Kuaana, Honolulu Stream and Kaluahinenui.
2. 2 Patches. Mauka Kamaka, Waialae Keoneau, Makai Nuuanu, Honolulu Kalama.

Claimant had this from Kalaiheanu in time of Kinau and held them in undisputed peace.

Kawelo sworn. Confirmed the above.

**1736 Kuahiwa [v 3/170]**

Umu sworn. I know this lot, ili Kiokapu, Waititi. Kalo land, 2 patches in one lot joined at the corners. Mauka are Kapaole and Mahuoekane, Waialae Kapu and Namaka, Makai Namaka and Uahuakane, Honolulu Kalaioia and Kapaole.

Claimant had this from Kanahi in time of Kinau about 1820, and has never been disputed as now bounded.

Kapaole sworn. Confirmed the testimony as above stated.

**1737 Kapaole [v 3/170]**

Umu sworn. This land in Kiokapu, Waititi in several lots.

1. House lot, 2 houses of Claimant and fenced. Mauka Kaihumua, Waialae Kaluahinenui, Makai Sea, Honolulu Kenau.
2. Kalo land, 1 patch. Mauka Kawelo, Waialae Kahaha, Makai Uanuai, Honolulu Luae.
3. Kalo Patch remnant 8 untaken. Mauka Kenoa, Waialae Kuhiwa, Makai also, Honolulu Kahahu.

Claimant had these lands from Kenae Konohiki in 1840 and held them undisputed to this time.

Kuahiwa sworn. Confirmed the previous testimony.

**Note: Kenae was the konohiki in 1840 of Kiokapu.**

**1748 Ono [v 3/173]**

Lehuanui. This is in Kanewai, Waititi.

House lot, 3 houses on Ono's, fence. Mauka Stream and Kaluahinenui, Waialae Kalama, Makai Kaa, Honolulu my land.

Claimant had this land from Kalama in time of Kinau, and has held it undisputed to this time.

Kawelo Confirmed the above.

**1750 Niha [v 3/174]**

Ono sworn. This land is in Kanewai, Waititi, Kula and Kalo.

1. House lot, fences. Mauka my land, Waialae Kalama, Makai Kauo, Honolulu Kalama.
2. Kalo, 5 Patches. Mauka Kaluahinenui, Waialae Kalama, Makai Kaluahinenui's, Honolulu my land.

Claimant had these lands from Kalama in 1839, and has held them in peace until 2 years since, when Kalama present Konohiki took both lots completely away. I do not know so much or any thing of the reasons as another witness, Kalama lives with me.

Lehuanui sworn. Confirmed the previous testimony in all parts.

Kawelo sworn. Agent for Kalama, states that Niha was dismissed because his land was overgrown with weeds.

**Note: Kalama is the konohiki of Kanewai.**

**1751 Aea [v 3/174]**

Nahinahi sworn. This land is in Piliamoo, Waititi, Kula and Kalo.

1. House lot, 1 house, no fence. Mauka is Kalama, Waialae Paukuwahie, Makai Kuahine, Honolulu Hopuhia.
2. Kalo, 1 patch. Mauka and Waialae Kalama, Makai Kukahiho, Honolulu Kalama.

Claimant had this from Kanehua in time of Kamehameha 1, and has had them undisputed to this time.

Keaha sworn. Knew all the testimony to be true.

**1758 Kalaione [v 3/177]**

Kakaione sworn. This land is in Kamokee, Waititi, 1 Kalo patch. Mauka is Kulewailehua, Waialae Stream, Makai Kulewailehua, Honolulu foot?

Claimant received this from Kulewailehua in 1836 and has never been disturbed since. Claimant is son in law to Kulewailehua.

Kuhau sworn. Confirmed the testimony as above.

**1760 Kuaileele, Claimant [v 14/477]**

Kane sworn say the land of Claimant consist of 3 pieces, in Kanukuaua 2, Waikiki, Oahu.

Apana 1, a Loi in Kanukuaua, is bounded: Mauka by Kapahulu of Kanaina, Kekaha by Kapahulu of Kanaina, Makai by the land of Kinikiu, Honolulu by the land of Manaole.

Apana 2 a ½ Loi in Kanukuaua is bounded: Mauka by the koele of Mahuka, Kekaha by the land of Kauaohilo, Makai by the land of Kauaohilo, Honolulu by the land of Wailehua.

Apana 3, Pahale in Kapua, Waikiki, is bounded: Mauka by the kula of Kapua, Kekaha by the house of Koa, Makai by the sea shore, Honolulu by the kula of Kapua.\

Claimant received the land from Mahuka in the year 1847, and held it until when he was taken sick, it was then taken from him for no attending upon the work of Konohiki.

Ku sworn says the above testimony is correct, and is also his own.

**1761 Kawaihae [v 3/185]**

Mano sworn. This land is in Palolo, Waititi, Kalo land 2 patches separate.

1. 1 Patch. Mauka Kakanui, Waialai Stream, Makai Pehu, Honolulu Palea.
2. 1 Patch. Mauka Upepe, Waialai Kakanui, Makai Palea, Honolulu Kuapahoa.
3. 1 Patch. Mauka Pehu, Waialai Stream, Upepe, Makai same, Honolulu Kaniho.
4. 1 Patch. Mauka Lolo, Waialai Kaiwi, Makai Pehu, Honolulu Lolo.

Claimant had these lands from Palea in time of Kamehameha 3<sup>rd</sup>, three years ago, he lived there from time of Rihoriho, and has always held in peace.

Palea sworn. I have these lots and the testimony is all true.

**1762 Kahonu Oct 29 [v 3/177]**

Nawaakaua sworn. My father died in 1828. He held his land from before time of Kamehameha 1. I was living in another place, but before I could get there the Konohiki Kukahiko too it away. It is situated in Mooiki, Waititi. It was Kalo land 4 Patches, but since it was taken away it had all dried up for lack of cultivation.

**Note Kukahiko was konohiki of Mooiki. Also that father owned BEFORE Kam. 1.**

**1762 Kapawa [v 3/177]**

Okilani sworn. This land is in Maulukikepa, Waititi, Kalo and Kula.

1. House lot, 1 house, fenced. Mauka is Hopuhia, Pahea land of Kahele is on Waialae side, Makai Kaauiwai, Honolulu Kahele.
2. Kalo ½ Patch. Mauka Pukawahie, Waialae W. Sumner, Makai Hopuhia, Honolulu Kahele.
3. Kalo 1 Row. Mauka and Waialae Hopuhia, Makai Loiloa, Honolulu Hopuhia.

Claimant had these lots from his Ancestors in time of Kinau. They have never been disputed from old time.

**1765 Kahikaele and Kamalie Oct 29 [v 3/177]**

Kahonu sworn. This place is in Moo-aina Niukukai, Waititi. Kalo and Kula.

1. House lot. 3 houses of Claimant and two others under him. No fence. Mauka a fishpond of Kehuanaoa, Waialae Malo's, Makai Sea, Honolulu Niopu.
2. Kalo 1 patch. Mauka Nihopu, Waialae Kaua?, Makai Kahaawepalu's, Honolulu Uahuawahine.

Claimant had these lands from Kehuanaoa in time of Kaahumanu, and has held them undisputed ever since.

Kalaone sworn. Confirmed the testimony as above.

**1769 Malaihi [v 3/193]**

Kaehu sworn. This land is in Maona, Waititi. Haamama, Kalo land and Kula in two lots.

1. Kalo Patches. Mauka is J.J., Waialai Kuhia, Makai Kanaina, Honolulu Kekuaanaoa.
2. 1 Patch and a little Kula. Mauka Apihi, Waialai Kealoha, Makai Keolohopauole, Honolulu Kekuaanaoa.

Claimant received this land from his father Huleole who died in Kaahumanu's time, and has held it to 1849 in peace, without dispute, but has been dispossessed of it by Kaauiwai this year, and Kaiahua now holds it (Konohiki W). I believe Claimant was dismissed from the land for taking too much water, the land was well cultivated and full of Kalo at the time. Claimant has a wife and daughter and relations with him.

**1770 Mano [v 3/185]**

Keiakapu sworn. This land is in Kikio, Waititi, Kalo land in several lots.

1. Kalo land, 2 Patches. Mauka Umauma, Waialai same, Makai Panioi, Honolulu Horse Road.
2. 6 Patches. Mauka Keawe, Waialai same, makai same, Honolulu Pehu.
3. 3 Patches. Mauka Palea, Waialai Keawe, Makai Keawe and Kekui, Honolulu Stream.
4. 1 Patch. Mauka Paele, Waialai same, Makai same, Honolulu Stream.
5. 3 Patches. Mauka Pehu, Waialai Stream, Mahai Pehu, Honolulu Victoria.

Claimant had these lots from met my husband in 1822, and never been disturbed.



**1771 Makoli [v 3/177]**

Kauhau sworn. This land is in Niukakai, Waititi, Kula and Kalo.

1. House lot, 1 house, partly fenced. Mauka is Kamaukole's, Waialua Kulewailehua, Makai my land, Honolulu Kekuanaoa.
2. Kalo land, 1 patch and stream. Mauka is Mahikona, Waialae Haumea, Makai my land, Honolulu Kanaina.
3. Kalo 2 patches. Mauka stream and my land, Waialae Pahi, Makai Kekuanaoa, Honolulu Haumea.

Claimant had these lands from his father in 1836, and the title has never been in dispute.

Kahonu confirmed the testimony.

**1773 Paualoha [v 3/185]**

Koa sworn. This land is in Moomoku, Waititi, consistin of Kalo land, 2 Patches.

1. 1 Patch. Mauka Kamakahonu, Waialai Kekukahiko, Makai Kamakahonu, Honolulu Ku.
2. 1 Patch. Mauka Kamakahonu, Waialai Kekuhiko, Makai Kamakahonu, Honolulu Kahilohaa.

Claimant had these lots from me in time of Kaahumanu 1, and has ever since held them undisturbed.

**1775 Pawa [v 3/181]**

Kalaione sworn. This land is in Pinaio, Waititi. House lot, 1 house, no fence. Mauka Govt Road, Waialae Govt Land, Makai Sea, Honolulu Sea.

Claimant received this land form Kaahumanu 1 and had ever since held it undisputed.

Alapai sworn. Confirmed the testimony above.

**1776 Pehu Oct 30 [v 3/181]**

Uano sworn. This land is in Palolo, Waititi, consisting of Kalo and Kula in several lots.

1. Kalo land 15 Patches and Kula. Mauka Piikoi, Waialae Mahuka, Makai G. Bush, Honolulu Kaniho.
2. Kula land partly cultivated. Mauka Pali, Waialae Piikoi and Makai, Honolulu, Pali.
3. Coconut lot. Mauka Kukahiko, Waialae Piikoi, Makai Kukahiko, Honolulu Keohalole.
4. Sea lot belonging to No. 3. Mauka G. Bush, Waialae Govt. Land, Makai to deep water, Honolulu Kukahiko.

Claimant received these ladns from the King last year or rather they were confirmed by him to claimant as described above. He has a writing to that effect from John Young. These lands were in possession of Claimant in time of Rihoriho.

Keekapu W (wahine) sworn. Knew all the preceding testimony to be correct.

**Note Sea claim out to deep water.**

**1777 Keaumalo [v 3/181]**

Koa sworn. This land is in Mookai, Waititi. Kalo land, 2 patches. Mauka Kuene, Waialae Makahonu, Makai Pahi, Honolulu SM Hiikoi.

Pahi gave claimant this land in time of Kaomi and has held it undisputed.

Kaunau sworn. Confirmed the above testimony.

**1778 Kawelo [v 3/181]**

Uaino sworn. This land is in Palolo, Waititi, in several lots.

1. Kalo land 2 Patches. Mauka Pehu, Waialai Hog Pen, Makai my land, Honolulu Keawe.
2. Kalo 1 Patch. Mauka and Waialai my land, Pehu, Makai Pehu, Honolulu Kehuu.
3. 1 Kalo Patch. Mauka my land, Waialai Pehu, Makai and Honolulu my land.
4. 1 Patch. Mauka my land, Waialai Keawe, Makai same, Honolulu Kui.

Claimant received these lands from Keiakapu Konohiki 1845, and held them in peace till his death last year 1848 when he willed them to his son Kaheananui, who had in consequence ever since and never been disputed.

Umauma sworn I know this claim and that the testimony now given is true.

Keiakapu also confirmed.

**Note: Keiakapu konohiki of Palolo in 1845.**

**1779 Puhilani [v 3/181]**

Kalakoa sworn. This land is in Uapapoi, Waititi, in one lot consisting of Kalo land 2 patches and 1 Kula.

Mauka Kahawahie, Waialai Kamaua, Makai Waiauaia Konohiki, Honolulu Kekuanaoa.

Claimant had this from Waiauaia in time of G. Paulet 1823, and has held it ever since undisputed.

Maka sworn. Confirmed the testimony above given.

**1780 Lahilahi [v 3/181]**

Kaai sworn. This land is in Kuilei, Waititi. Kalo land 12 Patches, some Kula and 1 house in one lot.

Mauka Waiauaia, Waialai Kapuhia, Makai, Honolulu Kanaina.

Claimant had this from William Sumner long before he died, and has held it undisputed ever since.  
Kaneakama sworn, Confirmed all the testimony. Claimant has had it ever since time of Kaahumanu.

**1781 Umauma [v 3/181]**

Mano sworn. This land is in Palolo, Waititi.

1. Kalo, 3 Patches and Kula. Mauka Uahana, Waialai Stream, Makai my land, Honolulu Road.
2. 1 Kalo Patch. Mauka Paele, Waialai Pehu, Makai Palea and Honolulu.
3. 1 Patch. Mauka Pehu, Waialai Paele, Makai same, Honolulu same.

Claimant had these lands from Keiakapu Konohiki who is present in time of Kaahumanu, and has held them undisputed.

Keiakapu sworn, I gave these lands as stated and the testimony is all true.

**Note: Keiakapu konohiki of Palolo.**

**1782 Kahope [v 3/181]**

Kauhau sworn. This is in Kukukai, Waititi, 1 Kalo patch. Mauka Kaluhiea, Waialai Keiahopuwale, Makai Hoa, Honolulu Kaia.

I gave this to Claimant in 1823 and he has held it undisputed ever since.

**1782 Kahope, Claimant [v 14/477]**

Kanemakua sworn say the portion of the claim of Kahope is Apana hale in Helumoa, Waikiki, Oahu.

It is bounded: Mauka by the coconuts of Kelumoa, Kekaha by the pahale belonging to me, Makai by the sea shore, Honolulu by the pahale of Okuu.

Claimant received the house lot from Kaahumanu in the time of Kaumualii and has held the same in undisputed possession ever since.

Kaia sworn says the above testimony is true and it also his own.

**1786 Maka [v 3/185]**

Kalahoa sworn. This land is in Peakea, Waititi, Kalo land 3 patches in one lot.

Mauka Epa, Waialai Pauka, Makai Kuanaoa, Honolulu Luaiku.

Claimant had this land from Kaaha Konohiki in 1847 and has held in peace to the present time.

Uhilani sworn Confirmed the previous testimony.

**Note: Kaaha was konohiki of Peakea.**

**1787 Pakiai [v 3/185]**

Kumuhonua sworn. This land is in Waialai, Waititi, consisting of Kalo and Kula.

1. Kula land. Mauka Paele and Pauao, Wailupe Paki, Makai Pulea, Honolulu Umaleli.
2. Kalo, 2 Patches. Mauka Kaiui, Wailupe Kauanui, Makai Kaiwe, Honolulu Kauanui.

Claimant received these lots from Kaula in time of Kaahumanu 1, and has ever since held them in peace.

Maikai sworn, Confirmed the testimony as above.

**1788 Pauoua [v 3/185]**

Kumuhonua sworn. This land is in Waialai, Waititi, Kula and 1 house and 3 Kalo Patches in one lot.

Mauka Kaili, Honolulu Kalauea and Kukee.

Claimant ha this lot from Kuhe Konohiki of Bolabola in time of Kaahumanu and has held it undisputed ever since.

Nahaikuaana sworn Confirmed the above.

**Note: Kuhe was konohiki of Waialai.**

**1789 Mahiai [v 3/185]**

Pawao sworn. This land is in Waialai, Waititi. Kalo land, 3 patches and stream, 1 Kula, 1 house, fenced in one lot.

Mauka Puahlulu, Wailupe Kauanui, makai Kaiwi, Honolulu Kuha.

Claimant had this land from Kohou in time of Kaahumanu 1, and has held it more than 50 years to my knowledge free from dispute.

Pahiae sworn, knew the previous testimony true.

**1790 Kaina [v 3/185]**

Kumuhonua sworn. This land is in Waialai, Waititi, consisting of Kalo 3 Patches, some Kula, 1 house and fenced. Makua Mahiai, Wailupe Pawao, Makai Helepololei, Honolulu Kaiwi. Claimant had this from Kuke in Kaahumanu's time and held it in peace ever since.

Mahiao sworn, Confirmed the previous testimony.

**1791 Kuaha 31 Oct [v 3/185]**

Kiwai sworn. This land is in Waialai, Waititi, consisting of several pieces.

1. House lot, 1 house, fenced partly. Mauka Stream, Wailupe my own land, Makai Kawaikaua, Honolulu Stream.
2. Kalo, 2 Patches. Mauka Kalau, Wailupe Kauanui, Makai Mahiae, Honolulu Kaiwi.
3. Kula uncultivated. Mauka Mahuka, Wailupe same, Makai same, Honolulu G. Bush.

Claimant received these lands from Kuke at time of Kaahumanu, or rather they were given to him to Kepalai his father in law, from whom they have descended. They have never been disputed.

**1792 Kuahiu, Claimant, Deceased [v 14/541]**

Makai, daughter in part of Konohiki, Kanehahu and Kimanawa, Daughter and as heir.

Kailuili sworn say the land of Claimant is an apana, Mooaina in Kaulu, Waialaeiki, Oahu.

3 Lois and auwai in one apana.

Apana 1 is bounded: Mauka by land of Pipi, Hoikina by koele of Kauluiki, Makai by land of Kaina, Honolulu by land of Kaiwi.

Apana 2, Kahuahale in Keahia, Waialaeiki,: Mauka by kula of Konohiki, Hoikina by kula of Konohiki, Makai by Kahakai, Honolulu by the muliwai of Keahia.

Claimant received the land from Kalawela in the time of Kaahumanu and has held it until his death.

**1803 Ohia [v 3/189]**

Kalakoa sworn. This land is in Waialai iki, Waititi, consisting of Kula and Kalo of 2 Patches.

Mauka Mahuka, Wailupe same, makai Loihau, Honolulu Punahou.

Claimant had this from Pau in time of Boki, and has ever since held it undisputed.

Kuhau sworn, This testimony I know to be all true.

**1813 Keaka, Claimant Waikiki April 29, 1850 [v 14/477]**

Claimant appeared and made oath that his claim has been duly made out and present by Keanui, he is therefore admitted to a hearing.

Aoa sworn say the land of Claimant contains 3 Lois in the ili Piliamoo, in one piece. It is bounded:

Mauka by the land of Paukuwahie Kiki, Kekaha by the land of Wahinano, Makai by the land of Kalawa, Honolulu by the land of Paihoiho.

Claimant received the land from Kanuia in the time of Kinau and has held quiet possession until now.

Kanepuaa sworn says the above testimony is true and is also his own.

**1816 Kaaha 3 Nov [v 3/194]**

Kalakou sworn. This land is in Hopoe, Waititi. Claimant is dead and his daughter lives on the land with her husband Kaanaana, her name is Kahele. Kaaha's wife's name is Kahikii. The land is Kalo and Kula in one piece, having 6 Patches of Kalo, and another piece of 1 Patch.

Mauka is Stream and Victoria, Waialai Paukuwahie and Victoria, Makai Kalakoa and Mauhele, Honolulu Kukahiko.

2 1 Patch. Mauka Stream, Waialai Paukaa, Makai Hepa, Honolulu Kahoipua.

Claimant received these lots from Kanaina in time of Kaahumanu, and has ever since held them undisputed. He died in 1848 when he willed it to his daughter.

Kaaha II sworn, Confirmed the testimony above, excepting the second lot in place and bounds. He does not know the bounds of the last but think those given are incorrect, the first lot is properly described.

**1823 Opu [v 3/195]**

Pakaihia sworn. This land is in Kaluaolohi, Waititi, consisting of Kalo and Kula, 3 Patches, 1 house on it.

Mauka Keoneana, Waialai Makaole, Makai Kawahineaea, Honolulu Konapahuelima.

Claimant had this from Kahauauuiaekai Konohiki in time of Kinau, and has held it ever since peacefully.

Kehele sworn, There is no counter to Claimant to this land and the testimony given is correct.

**1825 Kuewa [v 3/195]**

Kahulupi sworn. This is in Kaluaolohi, Waititi, Kula and Kalo 2 Patches, and 2 houses on it.

Mauka Keoneana, Waialae Kahanaumaik, Makai same, Honolulu also.

Claimant had this from Kaluahinenui in time of Kinau and has held it undisputed.

Kikele sworn, Confirmed the testimony above.

**1833 Manuiki, Claimant [v 14/477]**

Hoopuia Konohiki sworn say the land of Claimant contains 2 Lois and a Pauku auwai, in one piece and is bounded:

Mauka by land of Kaluauikee, Kekaha by land of Mookini, Makai by land of Hoopua, Honolulu by land of Moho.

Claimant received the land from me in the time of Kinau and has held the same in quiet until now.

Ohipua sworn says the testimony of Hoopua is true and has is also like it.

**1834 Ohipua, Claimant [v 14/477]**

Hoopua sworn say he knows the land of Claimant. It contains 1 Loi and an auwai in one piece and a Kahuahale in another.

Apana 1, the Loi is bounded:

Mauka by my land, Kekaha by land of Kaaka, Makai by land of mine, Honolulu by land of Haole.

Apana 2, Pahale house yard, is bounded: Mauka by kula of Kahakai, Kekaha by kula of Konohiki, Makai by kula of Konohiki, Honolulu by kula of Paakea.

Claimant received the land from me the Konohiki in the time of Kinau, and has held it in quiet until now.

Manuiki sworn says the testimony above is true, and is also his own.

**Note: Hoopua is the konohiki.**

**1844 Hulupu, Claimant [v 14/477]**

Kimo sworn say the land of Claimant contains 2 Lois and as auwai in the ili of Kaohiauau, Waikiki, Oahu.

It is bounded:

Mauka by the land of mine, Kekaha by the kahawai of Pahoa, Makai by Piliamoo ili aina, Honolulu by the ili of Kiki.

Claimant received the land from Heohuhu in the time of Kekauluohi, and has held the same in quiet until now.

Kalaikoloua sworn says the testimony of Kimo is true, and his own is like it.

**1873 Kamano, Claimant [v 14/477]**

Claimant appeared and made oath that his claim was dly made out by Kauniu and presented the same is therefore admitted to a hearing.

Nahana sworn say the land of Claimant is a Mooaina called Kapuna 2, in the ili Kapahulu, Palolo.

It is in one piece, contains about 10 Lois. The House lot is in another piece of Kapahulu.

Apana 1 is bounded:

Mauka by land Konohiki, Hoikina by land of Kekio, Makai by land of Poohiwi, Honolulu by land of Konohiki.

Claimant received the land from me in the time of Kekauluohi and has held it in quiet until now.

**1896 Nahana, Claimant [v 14/477]**

Claimant appeared and took oath that his claim has been duly sent in, and he is therefore admitted to a hearing.

Panawa sworn says the land of Claimant is Mooaina iloho o ha ili o Kapayulu, Palolo, Waikiki, contains 22 Lois and a kula in one piece. It is bounded:

Mauka by land of Konohiki, Hoikina by kula of Konohiki, Makai by the ili of Kekio, Honolulu by the kula of Konohiki.

Claimant received the aldn from Kaniho in the time of Kinau and has held quiet possession until now.

Kamano sworn confirms the above and says it is his own.

**1922 Kealohapauole [v 3/271]**

Kailiahi sworn. I know this land

No. 1 is 3 lois in Ili of "Kaulaa", Waititi, Oahu.

No. 2 is 3 lois in Ili of "Kaulaa", Waititi, Oahu.

No. 3 is 1 piece of Kula in "Kaulaa", Waititi, Oahu.

No. 4 is ½ of ahupuaa of Paihaalou, Hilo, Hawaii.

No. 1 is bounded: mauka by Uakaulio's lois; West by Kanakaihi's lois; U by Kailiulaula's lois; H by Kolowalu, an ili.

No. 2: Mauka Hoaipu's lois; W by Halalena Ili; U by No. 2; H by Kaaipu ili.

Aua sworn say the land of Claimant contains 1 Loi, 1 Auwai, he kula, and house lot, all in one piece on the ili of Auaukai, Waikiki, Oahu. It is bounded: Mauka by the kahawai of Hamohamo, Kekaha by the loi of Kapela, Makai by the loi of Okuu, Honolulu by the kula of Konohiki.

Claimant received the land from Kamaukoli in the time of Kaahumanu and has held the same in quiet until now.

Kanakaole sworn says the testimony of Aua is correct and his own is like it.

**6324 Kamehehu, Claimant [v 14/477]**

Kamaukoli sworn say the land of Claimant contains 3 Lois, a kula in one piece in the ili of Auaukai, Waikiki, and Apana 2 a house lot in Ulukou, Kalia, Waikiki.

Apana 1 is bounded: Mauka by Hamohamo, Kekaha by Hamohamo, Makai by Kalia, Honolulu by Kalia.

Apana 2, Kahuahale is bounded: Mauka by the hale of Kauai, Kekaha by the hale of Kamaukoli, Makai by the sea shore, Honolulu by the water course.

Claimant received the land from me in the time of Kaahumanu, and has held the same in quiet until now.

Aua sworn says the testimony above is correct and it also his own.

**6679 Manamana 2, Claimant [v 14/477]**

Kapela sworn say the land of Claimant contains 3 Lois in the ili of Auaukai, Waikiki, Oahu.

It is bounded: Mauka by the stream of Kualalua, Kekaha by the stream of Hamohamo, Makai by loi of Kalawaia, Honolulu by land belonging to myself.

Claimant received the land from Kamaukoli in the time of Kinau and has held ever since.

Kanakaole sworn says the testimony above is correct and his own is like it.

**6680 Kamaukoli, Claimant [v 14/477]**

Kamaukoli sworn say the land of Claimant contains 1 Loi in piece and a house and and a kula in another.

Apana 1 is in the ili of Auaukai, Waikiki, Oahu, and is bounded: Mauka by the land of Hamohamo, Kekaha by the land of Hamohamo, Makai by the land of Kalia, Honolulu by the land of Kalia.

Apana 2, house lot in Ulukou, makai of Waikiki. It is bounded: Mauka by the house lot of Kauai, Kekaha by the house lot of Kamaukoli, Makai by the sea shore, Honolulu by the water course.

Claimant received this land from Haukolu in the time of Kaahumanu, and has held the same in quiet until now.

Aua sworn says the above testimony is true and his own is like it.

**6749 Apolehua, Claimant [v 14/541]**

Lalakoa sworn say the land of Claimant is a Mooaina called Kaheepilau, Waialaeiki, Oahu.

It contains 3 Apana and the house lot is the 4<sup>th</sup>.

Apana 1, 1 Loi and is bounded: Mauka by land of Waiwaiole, Hoikina by land of Kaiwi, Makai by koele Kaheepilau, Honolulu by the auwai of Konohiki.

Kalaloha sworn says the above testimony is true it is also his own.

Apana 2, a kahawai and kula in Aalia, Waikiki. It is bounded. Mauka by the land of Kalamanamana, Kekaha by the land of Kualulua a kahawai, Makai by the land of Hamohamo no Konohiki, Honolulu by the land of Aaia in Kalia.

Apana 3, a house lot yard in Keomuku, Waikiki, bounded. Mauka by the loko of Helumoa of ili, Kekaha by the kula nui of Helumoa, Makai by the house lot of Kapule, Honolulu by the house lot of Puepue.

Claimant received the land from his father in law Kaanaukoli in the time of Kaahumanu and has held the same in quiet ever since.

Kahonu sworn, confirmed the above as true his also his own.

### **8269 Okuu, Claimant [v 14/477]**

Kahuna sworn say the land of Claimant contains 2 Lois in Auaukai, Waikiki, Oahu, in one piece and is bounded: Mauka by the loi of mine, Kekaha by the loi of Kapala, Makai by the loi of Konohiki, Honolulu by the loi of mine.

Claimant received the land from Kamaukoli in the time of Kaahumanu, and has held the same quiet until the present time.

Kanakaole sworn says the above testimony is true and is also his own.

### **8282 Keaka, Claimant [v 14/477]**

Claimants land has been taken by Konohiki, and confirmed by the Lunaaukau.

**8285 Keawe, Claimant [v 14/477]**

Claimant appeared and made oath that he has regularly made out his claim and presented it.

Keokapu sworn says the land of Claimant contains 2 Apana and is a Mooaina in Kekio, Palolo, Waikiki and is bounded.

Apana 1: Mauka by land of Konohiki, Hoikina by the Pa aina, Makai by the land of Konohiki, Honolulu by the land of Kekui.

Apana 2 is bounded: Mauka by land of Konohiki, Hoikina by land of Huwelo, Makai by yard of my house, Honolulu by kula of Kekio.

Claimant received the land from Pehu in the time of Liholiho, and has held it in quiet until now.

Kawaihae sworn says his testimony agrees in the above which is true.

**8287 Kawainui Claimant [originally 3744 Wainui] [v 14/477]**

Claimant appeared and made oath that his claim was made out by Nahakuelua and presented to the Land Commission, the same is therefore admitted to a hearing.

Pakui sworn say the land of Claimant is a Mooaina called Makaha in the ili of Waiomao, Palolo, Waikiki. It is in 1 Apana, contains 8 Lois and a Kula.

Is is bounded: by land of Konohiki on all sides.

Claimant received his land from Opunui in the time of Kinau and has held the same in quiet until now.

Kinoua sworn says the above testimony is true, it is also his own.

**8290 Kinoua, Claimant [originally 3735-B] [v 14/477]**

Claimant appeared and made oath that his claim was duly made out and presented by Nahakuelua the same and therefore admitted to a hearing.

Kawainui sworn say the land of Claimant is a Mooaina called Kahoana, ili of Waiomao, Palolo. It contains 6 Lois and a kula in one piece. It is bounded:

Mauka by land of Konohiki, Hoikina by land of Konohiki, Makai by land of Hoapuku, Honolulu by land of Konohiki, the Kahawai.

Claimant received the land from Opunui in the time of Kinau, and held it still in quiet.

Pa sworn says the above testimony is true and is also his own.

**8559 G. Kanaina Part 52 [v. 3/269]**

This claim is for the ili of Kapahulu, Kona, Oahu, Ahupuaa of Waititi.

Kealiiielele sworn, I know the ili of Kapahulu, it is in Waikiki, Oahu, district of Kona; consisting of 2 pieces of kalo land and 5 of Kula.

1: 5 moos called "Heapuna" Kalo.

2: 1 moos called "Hoaka" and a fish pond.

3: 1 moo uala Lolilehua.

4: 1 moo called "Puoiili".

5: 1 moo Kula "Kaanainui."

6: 2 moos ualu "Puea."

7: 1 moo Kula "Wiliwilimaumai."

Claimant title was from Kekauluohi, Premier, who had this ili from Kekaulike in Liholiho's time, and has been possessed in peace to this time, with the exception of No. 5 which is claimed by Victoria as part of "Waialae." No. 5 is also claimed by the widow of Pehu. I think it is Kanaina's lands because it is part of Kapahulu. I am not a very old resident there.

The kula, mauka of the road "Makahuna", is the land of Pehu, called "Kekio", but that makai of the road is Kapahulu, though it is claimed as part of Waialae.

Uahana sworn. I am a kamaaina of Palolo, I know the land in dispute, called "Kaananauinui". From the time of Kamehameha 1 I have known it, and it has always been said to belong to "Kapahulu." There are about 10 Natives who have sent in claims for portions of the Kalo land in Kapahulu, the land mauka of the Road called "Makahena", is called "Kekio", and belongs to the widow of Pehu, the land makai of the road is the part in dispute, and belongs to Kapahulu.

Kauhapa sworn. I am a kamaaina of Palolo, and know the land in dispute "Kaananauinui" it is a part of Kapahulu, and I fully verify the testimony of Uahana.

Kumuhonua sworn. I am a Kamaaina of Palolo and Waialae, and know the land of "Kaanainui" in dispute; it belongs to Waialae the land of Victoria. Kekio is all mauka of the road Uakahana.

Kepo sworn. I am a Kamaaina of Waialae and know the land in dispute, and have known it from before the conquest of this island by Kamehameha 1: it is called "Kaanainui" and belongs to Waialae. The dividing line between Kapahulu and Waialae is as follows:

Commencing at "Kaialuahi", a point up in the mountains, thence to "Pohakuaumiumi", thence to "Kaauaniau", a large stone, thence to stone "Puukuaaka", thence to "Kalapo", thence to the Cape of "Kupikipikiio". Kekio is up mauka of the road Makahuna.

Kuapuu sworn. I am a Kamaaina of Waialae and was born there and have lived there all my life. In Kaahumanu's time my father an old Resident, took me with him and showed me all the boundaries of all the lands round about. The bounds of Waialae, Kapahulu side are as said by Kepo the last witness.

Kekio is a land mauka of the Road of Makahonu and a small piece makai Kapua a sea and a cocoa nut grove, "Kiiki".

Kehea sworn. I am a Kamaaina of Waialae, and have always lived there. I know its bounds, and they include the disputed land of "Kaanainui". I have known them from the days of Kamehameha 1.

Kaula sworn. I have lived at Waialae since the death of Kaahumanu 1. My knowledge of the boundaries of Waialae is the same as given by three former witnesses. My brother, a very old kamaaina of Waialae pointed out the boundaries to me.

Claimant received the land from Kamaukoli in the time of Kaahumanu and has held the same in quiet until the present time.

Keaho sworn says the testimony of the above is correct and is his own.

**10169-B Mahoe, Claimant [originally 3741] [v 14/477]**

Claimant appeared and made oath that his claim was duly made out and presented by Kanae, the is therefore admitted to a hearing.

Kahakauwila sworn say the land of Claimant is a Mooaina called Hoopinui, ili of Pukele, Palolo, Waikiki. It is in 2 pieces, the land and the house lot.

Apana 1 is bounded:

Mauka by land of Konohiki, Hoikina by land of Umiumi, Makai by land of Kolihana, Honolulu by land of Konohiki.

Apana 2, Hale is situated in Moopili, Pukele and is bounded: Mauka by kula of Konohiki, Hoikina by kula of Konohiki, Makai by kula of Konohiki, Honolulu by kula of Konohiki.

Claimant received the land from Papanaha in the time of Kekauluohi and has held it in quiet until now.

Kolihaua sworn confirms the above as true and says his own is like it.

**10535 John Napahi [v 14/477]**

Ku sworn say he know the land of Claimant. It is an ili aina called Kamookahi 1 in Waikiki, Oahu. It is bounded:

Mauka by ili aina Pahupahuapuaa of Kaioilani, Kekaha by ili aina Pahupahuapuaa of Mahuka, Makai by ili aina Kawaiaala, Honolulu by ili aina Mooluku of Naeole.

Apana 2. Loi lele in Mookahi 24 Lois, is bounded: Mauka by the ili aina Pahoa of Mr. Young, Kekaha by the ili aina Kalualohe of Kanaumaikai, Mauka by the ili aina Pahupahuapuaa, Honolulu by the ili aina Kamoku of Kuluwailehua.

Claimant received the above land from Liholiho, and has held quiet possession of the same until now. In the distribution of land by the king among his follows the above land was ofsigned to Claimant.

Kanemakua sworn confirms the foregoing testimony as true and is also his own.

Apana 2 is bounded. Mauka by the Wuniu, Kekana by the house of Kuawa, Makai by the sea shore of Hamohamo kai, Honolulu by the house of Kaa.

Claimant received the land from me in the time of Kaahumanu and has held it in quiet ever since.

Kahoe sworn says the above testimony is true and his own is like it.
